## OAKLAND CITY COUNCIL RESOLUTION NO. 87750 C.M.S.

RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO APPLY FOR AND ACCEPT THE U.S. DEPARTMENT OF AGRICULTURE CHILD AND ADULT CARE FOOD PROGRAM GRANT FROM THE CALIFORNIA DEPARTMENT OF EDUCATION IN AN ESTIMATED AMOUNT OF \$249,723 TO PROVIDE FUNDING FOR NUTRITIOUS MEALS FOR THE HEAD START/EARLY HEAD START PROGRAM FROM JULY 1, 2019 THROUGH JUNE 30, 2020

**WHEREAS**, the City of Oakland desires to apply for and accept a US Department of Agriculture (USDA) Child and Adult Care Food Program (CACFP) Grant in an estimated amount of \$249,723 from the California Department of Education ("CDE") to fund a Head Start/Early Head Start child nutrition program from July 1, 2019 through June 30, 2020; and

WHEREAS, the City's Fiscal Year (FY) 2019-2020 Proposed Budget includes \$249,723 in appropriations in the Department of Agriculture Fund (2102), HS Classroom and Seasonal Org (78231), Head Start FY19-20 CCFP Project (1004469), Strengthening Children, Youth & Families Program (YS13) for FY 2019-2020 for the CACFP grant; and

WHEREAS, the CDE Child Nutrition and Distribution Division will provide funds for comprehensive nutrition services to approximately 300 Head Start and Early Head Start children, who have the most economic need, with ten percent of the enrollment consisting of children with special needs; now, therefore, be it

**RESOLVED:** That the City Administrator or her designee is hereby authorized to submit an application to the CDE for USDA CACFP funds to operate a Child Care Food Program for children enrolled in the Oakland Head Start and Early Head Start program from July 1, 2019 through June 30, 2020, and to accept said funds in an estimated amount of \$249,723, and be it

**FURTHER RESOLVED:** That the City Administrator is hereby authorized to accept and appropriate any additional funding that may become available from this grantor (USDA), for the same purposes (CACFP), within the existing grant term, July 1, 2019 to June 30, 2020, without returning to Council; and be it
