OAKLAND CITY COUNCIL RESOLUTION NO. 877 E2 = C.M.S.

RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO APPLY FOR AND ACCEPT THE CALIFORNIA PRE-KINDERGARTEN SUPPLEMENTAL GRANT IN AN AMOUNT OF \$32,500, AND THE CALIFORNIA STATE PRESCHOOL PROGRAM EXPANSION GRANT IN AN AMOUNT OF \$1,225,109 FROM THE CALIFORNIA DEPARTMENT OF EDUCATION TO FUND PREKINDERGARTEN AND FAMILY LITERACY SERVICES FROM JULY 1, 2019 TO JUNE 30, 2020; AND AUTHORIZING A CONTRIBUTION FROM THE GENERAL PURPOSE FUND IN THE AMOUNT EQUILVALENT TO CENTRAL SERVICES OVERHEAD COSTS ESTIMATED AT \$152,447

WHEREAS, the City of Oakland wishes to apply for and accept a grant in an estimated amount of \$32,500 from the California Department of Education to fund California Pre-Kindergarten Supplemental Program (CPKS) from July 1, 2019 to June 30, 2020; and

WHEREAS, the FY2019-2020 Proposed Budget includes an appropriation of \$32,500 for the CPKS grant in the California Department of Education Fund (2138), HS Classroom and Seasonal Org (78231), Head Start CSPP FY19-20 Project (1004473), and Strengthening Children, Youth & Families Program (YS13); and

WHEREAS, the City of Oakland wishes to apply for and accept a grant in an estimated amount of \$1,225,109 from the California Department of Education to fund California State Preschool Program (CSPP) prekindergarten and family literacy services from July 1, 2019 to June 30, 2020; and

WHEREAS, the FY2019-2020 Proposed Budget includes an appropriation of \$1,225,109 for the CSPP grant in the California Department of Education Fund (2138), HS Classroom and Seasonal Org (78231), Head Start CSPP FY19-20 Project (1004472), and Strengthening Children, Youth & Families Program (YS13); and

WHEREAS, these grant fundings will be used to provide a prekindergarten and family literacy program in ten Head Start/CSPP sites in Oakland; and

WHEREAS, the program will provide child development, parenting education and family literacy services to a total of 244 eligible three and four year-old children and their families; now, therefore, be it

RESOLVED: That the City Administrator or her designee is hereby authorized to submit an application to the Department of Education, California Pre-Kindergarten Supplemental Program, for the CPKS grant for prekindergarten and family literacy services from July 1, 2019 through June 30, 2020, and to accept said funds in an estimated amount of \$32,500; and be it

FURTHER RESOLVED: That the City Administrator or her designee is hereby authorized to submit an application to the Department of Education, California State Preschool Program, for the CSPP grant for prekindergarten and family literacy services from July 1, 2019 through June 30, 2020, and to accept said funds in an estimated amount of \$1,225,109; and be it

FURTHER RESOLVED: That all central services overhead charges associated with these grants in an estimated amount of \$152,447 be offset through a contribution of the General Purpose Fund due to administrative cost limitations; and be it

FURTHER RESOLVED: That should additional grant funds be received from the grantor (California Department of Education) for the same purposes within the existing grant term, the City Administrator or her designee is hereby authorized to accept and appropriate the grant funds without returning to Council within the duration of the grant term July 1, 2019 – June 30, 2020; and be it

FURTHER RESOLVED: That the City Council hereby authorizes the City Administrator or her designee to conduct all negotiations, execute and submit all documents including but not limited to applications, agreements, amendments, modifications, payment requests, and related actions which may be necessary to apply for, accept and appropriate the aforementioned grant.
