ORDINANCE AMENDING OAKLAND MUNICIPAL CODE TITLE 5, CHAPTER 5.04, SECTION 5.04.480 AND SECTION 5.04.481, TO REDUCE TAX RATES FOR CANNABIS BUSINESSES WITH GROSS RE-CEIPTS LESS THAN OR EQUAL TO \$500,000.00

This ordinance will reduce the City of Oakland's tax rate for cannabis businesses from \$50.00 per \$1,000.00 of gross receipts or fraction thereof for medical cannabis businesses and \$100.00 per \$1,000.00 of gross receipts or fraction thereof for nonmedical cannabis business to \$1.20 per \$1,000.00 of gross receipts, or fractional part thereof, for any cannabis businesses with total annual gross receipts equal to or less than \$500,000.00. The City of Oakland's tax rate for cannabis businesses with total annual gross receipts greater than \$500,000.00 will remain unchanged
