President Kaplan and Members of the City Council:

Pursuant to Section 401 of the Charter, the City Attorney has prepared and requests your approval of the resolution authorizing compromise and settlement of the above-entitled claim for the sum of Thirty-Six Thousand Six Hundred and Sixty-Six Dollars and Sixty-Seven Cents (\$36,666.67).

This matter arises from an incident on October 19, 2015, wherein the guardrail and fencing became detached from the 23rd Avenue overpass and fell onto the 1-880 freeway below, resulting in an accident that caused personal injuries and property damage to Carlitta Collins.

The Council authorized settlement of this case in Closed Session on Tuesday, July 16, 2019 (moved by Councilmember Lynette Gibson McElhaney and seconded by Councilmember Noel Gallo – 8 Ayes).


