On behalf of the Board, Principal Champions & Advisors, the Museum of Jazz and Art would like to thank you, the City Council Members and the Mayors Office for your leadership, efforts & interest in sustaining culture. Please allow this letter as an official indication that the Board of Directors of the Museum of Jazz & Art (MOja), a non-profit 501(c)(3) public benefit corporation wish to enter Directly into an Exclusive Agreement with the City of Oakland for the 1310 Oak Street (Fire Alarm Building, FAB) site.

Museum of Jazz & Art (MOja) is planning a new 70,000 square feet Museum, on a City of Oakland Opportunity Site for Adaptive Reuse, with 3-levels of Galleries, Restaurant, Café, Auditorium, music studio and History-Hope-Heritage educational center overlooking Lake Merritt & plan to restore the existing Unreinforced Masonry & "Historically Significant" 1310 Oak Street, Fire Alarm Building (without existing Building demolition).

For 6+ years we have Researched around the World the best Museum Models & built the best team to implement this Community Benefit Project in Oakland.
