RECOMMENDATION

Staff Recommends That The City Council Adopt A Resolution Authorizing The City Administrator Or Her Designee To Enter Into A Professional Services Agreement With V&A Consulting Engineers for Engineering Services For The Sanitary Sewer Master Plan Project No. 1004788 In An Amount Not To Exceed Two Million Four Hundred Eighty-Six Thousand Six Hundred Sixty-Six Dollars (\$2,486,666).

EXECUTIVE SUMMARY

Approval of the resolution will authorize the City Administrator or her designee to execute a professional service contract with V&A Consulting Engineer in an amount not to exceed \$2,486,666. The work to be completed under the project will produce a comprehensive Sanitary Sewer Master Plan that will meet both federal and state regulatory requirements. The master plan will provide technical guidance to both the sanitary sewer rehabilitation capital improvement program and the sanitary sewer operation and maintenance program in compliance with the 2014 Consent Decree for the next 17 years. The contract term will be two (2) years. Funding for this project is available in the Fiscal Year 2019-21 budget. Additional funding will be from Environmental Protection Agency (EPA) Sewer Cleaning Project No. 1001676.

BACKGROUND / LEGISLATIVE HISTORY

The City of Oakland owns and operates a sanitary sewage collection system that serves approximately 400,000 people within the City. The collection system includes approximately 930 miles of gravity main, less than five (5) mile of pressure force main, and eleven (11) sewage pump stations. There are approximately 102,000 private lateral sewer connections to the collection system. The wastewater from Oakland flows to East Bay Municipal Utility District (EBMUD) facilities, together with sewage from seven Satellite Agencies including the Cities of Alameda, Albany, Berkeley, Emeryville, Piedmont, and Stege Sanitary District. During heavy storm events, excessive wastewater caused by stormwater inflow and infiltration from each sewer collection system overloads EBMUD treatment facilities and is diverted to three Wet Weather Facilities (WWFs) discharging into San Francisco Bay.

On September 22, 2014, a Sewer Consent Decree was finalized requiring EBMUD and the seven Satellite Agencies to stop discharging into the San Francisco Bay during heavy storms until 2036. Additionally, the Consent Decree requires mid-course check-in of the WWFs in 2022 and 2030. If the collective activities of all the defendants (EBMUD and the seven Satellite Agencies) do not yield the predicted progress towards slowing flows to the WWFs by the check-in periods of 2022 and 2030, a strategic Performance Evaluation Plan (PEP) and resultant Revised Work Plan (RWP) must be developed and implemented.

As part of the Consent Decree, the City of Oakland is required to replace an average annual rate of 13 miles of sanitary sewer mains, rehabilitate connected manhole structures, upgrade sewer capacities, evaluate system condition on a 10-year cycle, conduct cleaning on a 5-year cycle, and perform spot repairs on an as-needed basis.

A comprehensive Sanitary Sewer Master Plan will provide technical guidance to both the sanitary sewer rehabilitation capital improvement program and the sanitary sewer operation and maintenance program in compliance with the 2014 Consent Decree for the next 17 years.

ANALYSIS AND POLICY ALTERNATIVES

Selection Process

The City conducted a request for proposal (RFP) on May 24, 2019. On July 21, 2019 the City received one (1) proposal from V&A Consulting Engineers. Staff reviewed the proposal and invited V&A Consulting Engineers for presentation and interview. The firm was evaluated based on the following criteria:

- Approach Methodology and understanding of issues
- Experience Knowledge and experience of the project team
- Team Depth and breadth of the consultant expertise

The V&A Consulting Engineers was recommended for the work and they meet the City of Oakland's Professional Services Goals Local Business Enterprise/Small Local Business Enterprise (LBE/SLBE). They were recommended because they demonstrated relevant experience and familiarity with sanitary sewer system hydraulic modeling and master planning for numerous communities which are subject to similar regulatory requirements. Their team also presented cohesive and responsive approach to Oakland specific issues related to the sewer system constraints and analysis of various alternatives. The V&A Consulting Engineers LBE and SLBE participation is 51% (See Contract Compliance evaluation result in *Attachment A*).

Adoption of this resolution will allow the City Administrator or her designee to execute a professional service contract with V&A Consulting Engineer. The consultant will conduct field investigations, develop hydraulic model and risk-based asset management model, perform technical analysis, and produce master plans for both sanitary sewer rehabilitation and operation/maintenance programs.

Key benefits of the project will include:

- The proposed programs will be established in conjunction with the Capital Improvement Prioritization Program, which focuses on equity in Oakland;
- The risk-based analytic approach will help City mitigate inflow/infiltration sewer infrastructure more effectively and efficiently;
- The hydraulic modeling expands to 8-inch sewer pipeline, which will identify sewer capacity deficiency and help plan on capacity upgrades; and
- The master plan will provide technical responses to several what-if scenarios relevant to Consent Decree mid-course check-ins as well as sewer rate guidance on how to cover additional costs in the future.

The project is scheduled to begin in January 2020 and be completed by November 2021. The project schedule is shown in *Attachment B*.

FISCAL IMPACT

The total one-time cost to implement this project is \$2,486,666, of which \$2,000,000 is included in the Fiscal Year (FY) 2019-21 Budget in Fund 3100 Sewer Service Fund, Organization 92244 Sanitary Sewer Design Organization, Project No. 1004788. The remaining portion of the project cost will be transferred from existing appropriation in EPA - Sewer Cleaning Project No. 1001676. A breakdown of the appropriated project funding source is included in **Table 1**:

PUBLIC OUTREACH / INTEREST

The resultant sanitary sewer master plans will make changes to both the capital improvement program and the operation/maintenance program. The findings and recommendations will be presented to the Public Works Committee and/or City Council.

The work to be done under the contract was coordinated with Oakland Public Works (OPW) Bureau of Maintenance and Internal Services, and the Contracts and Compliance Division of the City Administrator's Office. In addition, the Office of the City Attorney and the Budget Bureau have reviewed this report and resolution.

SUSTAINABLE OPPORTUNITIES

Economic: A functioning sanitary sewer system improves the community and makes Oakland more attractive for residents and businesses. Sewer overflows cause economic hardships and result in fines by the EPA of a maximum of \$27,500.00 per day.

Environmental: The improvements to the sanitary sewer system will reduce the possibility of overflows, thereby, benefiting the environment.

Race and Equity: This project is part of the citywide program to eliminate wastewater discharges and overflows, thereby benefiting all Oakland residents with decreased sewer overflows and improved infrastructure.



RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR OR HER DESIGNEE TO ENTER INTO A PROFESSIONAL SERVICES AGREEMENT WITH V&A CONSULTING ENGINEERS FOR ENGINEERING SERVICES FOR SANITARY SEWER MASTER PLAN PROJECT NO. 1004788 IN THE AMOUNT NOT TO EXCEED TWO MILLION FOUR HUNDRED EIGHTY-SIX THOUSAND SIX HUNDRED SIXTY-SIX DOLLARS (\$2,486,666)

WHEREAS, In accordance with federal and state regulatory requirements, a comprehensive sanitary sewer master plan is needed for the Sewer Collection System asset management in Oakland; and

WHEREAS, The master plan will provide technical guidance to both the sanitary sewer rehabilitation capital improvement program and the sanitary sewer operation and maintenance program in compliance with the 2014 Consent Decree in the next 17 years; and

WHEREAS, The City conducted a competitive Request for Proposals (RFP) selection process; and

WHEREAS, On June 21, 2019, the Contract Services received a proposal from V&A Consulting Engineers for Oakland's Sanitary Sewer Master Plan (Project No. 1004788); and

WHEREAS, After reviewing the proposal and conducting an evaluation process including presentation and interview, V&A Consulting Engineers was recommended as the most qualified consultant to perform the services; and

WHEREAS, The total one-time cost to implement this project of \$2,486,666 is funded through the following project accounts as part of Fiscal Year (FY) 2019-21 Budget: Fund 3100 Sewer Service Fund, Organization 92244 Sanitary Sewer Design Organization, Sewer Account 57411, Project No. 1004788, \$2,000,000; Fund 3100 Sewer Service Fund, Organization 30533 Sewer Operation and Maintenance Organization, Sewer Account 54919, Project No. 1001676, \$486,666; and

WHEREAS, V&A Consulting Engineers and its team comply with all City's LBE/SLBE requirements for professional services; and

WHEREAS, V&A Consulting Engineers will conduct field investigations, develop hydraulic model and risk-based asset management model; perform technical analysis; and produce master plans for both the sanitary sewer capital improvement program and the sanitary sewer operation and maintenance in the next seventeen (17) years; and

WHEREAS, V&A Consulting Engineers has submitted a comprehensive proposal for each task and cost within a reasonable time frame; and

WHEREAS, The City Administrator has determined that this contract is for services of a professional, scientific or technical and temporary nature; and

WHEREAS, The City Administrator has determined that this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive service; now, therefore, be it

RESOLVED: That the City Administrator or her designee is hereby authorized to enter into an agreement with V&A Consulting Engineers, to provide professional Engineering Services for Oakland's Sanitary Sewer Master Plan Project No. 1004788 in an amount not-to-exceed Two Million Four Hundred Eighty-Six Thousand Six Hundred Sixty-Six Dollars (\$2,486,666); and be it
