President Rebecca Kaplan and Members of the City Council:

Pursuant to Section 401 of the City Charter, the City Attorney has prepared and requests your approval of a resolution authorizing the compromise and settlement of the above-entitled action. Due to the risk of an adverse jury verdict under the circumstances settlement is recommended in the sum of Two Million and Five Hundred Thousand Dollars payable to Plaintiff Sebastian Sanchez and his attorneys, Panish Shea & Boyle.

This action arises from an incident on May 20, 2016, wherein Mr. Sanchez and Oakland Police Department Officer Yusef Ghazi were involved in an automobile collision on 81<sup>st</sup> Avenue near International Boulevard, in Oakland. Mr. Sanchez allegedly suffered multiple bodily fractures in the ankle, knee, and hips, a dislocated shoulder, and traumatic brain injury. Mr. Sanchez claims past and future medical expenses, costs for future care, and pain and suffering.

The Council authorized settlement of this case in Closed Session on Tuesday, September 17, 2019 (moved by Councilmember Noel Gallo and seconded by Vice Mayor Larry Reid – 8 Ayes).
