RECOMMENDATION

Staff Recommends That The City Council Adopt A Resolution Authorizing The City Administrator Or His Or Her Designee To Apply For, Accept And Appropriate Grant Funds From The California Department Of Housing And Community Development In An Amount Not To Exceed The Maximum Program Limit Under The CalHome Program For First-Time Homebuyer Mortgage Assistance Programs.

REASON FOR SUPPLEMENTAL

At the Community and Economic Development Committee meeting on December 3, 2019, the Committee requested a detailed breakdown of the demographics of CalHome loan subsidies provided.

Table 1 below shows the loan recipients' responses (from inception of the program through the present) regarding their race/ethnicity.

The Greenlining Institute and the National Community Reinvestment Coalition (NCRC) assessed home purchase lending in Oakland and in their 2017 report on lending inequities, they found that communities of color do not access home purchase loans at rates comparable to non-Hispanic Whites, citing African Americans as extremely underrepresented.

As compared to the general population's data, CalHome applicant responses show that purchases assisted with a CalHome subsidy had a significant increase in mortgage lending to African American households (see **Table 2** below). CalHome loans increase equity in Oakland.
