Staff Recommends That The City Council Receive The 2019 Measure Z Policing Services Annual Evaluation Report by Resource Development Associates (RDA)

EXECUTIVE SUMMARY

At the January 27, 2020 Safety and Services Oversight Commission's (SSOC) regular meeting, the Year 3 (2019) Annual Evaluation of Measure Z Policing Services (**Attachment A**) was presented by RDA. The findings and recommendations from that report will be presented to the Public Safety Committee by RDA.

BACKGROUND / LEGISLATIVE HISTORY

In October 2016, the SSOC forwarded a recommendation to the City Council, who subsequently approved a contract in November 2016 with RDA to annually evaluate the Measure Z funded geographic and community policing services programs provided by the Oakland Police Department (OPD). Measure Z legislation requires the evaluation to be conducted by an independent research organization. RDA meets that requirement.

ANALYSIS AND POLICY ALTERNATIVES

In the attached report, RDA presents findings and recommendations on the progress and implementation of Measure Z-funded geographic and community policing services, particularly the utilization of Crime Reduction Teams (CRTs) and Community Resource Officers (CROs) in relation to Measure Z's objectives and the larger violence prevention and intervention goals of the City and OPD.

Environmental: There are no environmental opportunities identified in this report.


Race and Social Equity: The findings from this evaluation will help inform the community and the City of Oakland leadership determine the effectiveness of Community Policing in Oakland.
