

INTRODUCED BY COUNCILMEMBER LOREN TAYLOR

**RESOLUTION AUTHORIZING REIMBURSEMENT FOR
COUNCILMEMBER LOREN TAYLOR'S COSTS OF
APPROXIMATELY \$2,800.00 FROM THE COUNCIL CONTINGENCY
FUND FOR TRAVEL TO WASHINGTON, DC FOR ATTENDANCE AT
THE NATIONAL LEAGUE OF CITIES' CONGRESSIONAL CITY
CONFERENCE FROM MARCH 8 - 11, 2020**

WHEREAS, City Council Resolution No. 82800 C.M.S. approved by Council on June 1, 2010 establishes a policy that Councilmembers, when seeking Council approval for travel, shall indicate whether City funds will be used when travel involves airline transportation and lodging and shall provide an estimate of the cost of airline, lodging, per diem and conference fees when City funds are used as well as the source of City and/or Redevelopment Agency funding that will be used to cover the travel costs; and

WHEREAS, the City of Oakland is a Member City of the National League of Cities; and

WHEREAS, the Council President appointed and the Council approved Councilmember Loren Taylor as the first alternate Conference Voting Delegate to the National League of Cities' 2019 Annual Conference in March 2019; and

WHEREAS, in November 2019, during the National League of Cities Conference in San Antonio, TX, Councilmember Loren Taylor was elected Assistant Treasurer by the National Black Caucus of Local Elected Officials; and

WHEREAS, the National League of Cities' Congressional City Conference taking place from March 8 - 11, 2020 is an opportunity for local elected officials and policy leaders to discuss common challenges and new trends affecting cities and proven best practices to improve local communities; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the cost for Councilmember Loren Taylor's travel to Washington, DC is approximately \$380.00 for airfare, approximately \$740.00 in conference fees, up to \$198.00 in per diem costs for four days for a total of approximately \$792.00, and approximately \$1,482.00 in total lodging costs for the four nights; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the source of City funding that will be used to cover the travel costs will be from the City Council Contingency Project fund; and

WHEREAS, Councilmember Loren Taylor seeks Council approval of the aforementioned estimated costs; now, therefore, be it

RESOLVED: That all expenses incurred for said travel of Councilmember Loren Taylor to attend the National League of Cities' Congressional Conference in Washington, DC from March 8 – 11, are hereby authorized for reimbursement.


