RESOLUTION APPOINTING COUNCILMEMBER NOEL GALLO TO THE EAST BAY REGIONAL COMMUNICATIONS SYSTEM AUTHORITY (EBRCSA) BOARD OF DIRECTORS, AND APPOINTING COUNCILMEMBER SHENG THAO AS AN ALTERNATE TO THE EBRCSA BOARD OF DIRECTORS COMMENCING MARCH 6, 2020

WHEREAS, the East Bay Regional Communications System Authority (EBRCSA) was formed as a Joint Powers Authority in 2007 to serve Alameda and Contra Costa counties' public safety communications needs; and

WHEREAS, the EBRCSA Board of Directors has 23 members; and

WHEREAS, at its September 21, 2015 meeting, the City Council adopted Resolution No. 85780, which authorized the City Administrator to enter into Letter Agreements with the Alameda County Fire Chiefs Association, Alameda County City Managers Association, and the Alameda County Elected Officials (Mayor's Conference), under which each association will dedicate one of their voting seats on the EBRCSA Board of Directors to the city of Oakland; and

WHEREAS, the City Administrator entered into a Letter Agreement with the Mayor's Conference that dedicates one of its three seats to a City of Oakland elected official; and

WHEREAS, the City Council's Rules of Procedure, Rule 6, (Resolution No. 87044 C.M.S.) provide that "the President of the Council shall recommend appointments to regional and local boards and agencies, as appropriate, subject to confirmation by the Council"; now, therefore, be it

RESOLVED: That Councilmember Noel Gallo is hereby appointed to serve on the EBRCSA Board of Directors as a city representative for the City of Oakland; and

FURTHER RESOLVED: That Councilmember Sheng Thao is hereby appointed to serve as an alternate city representative for the City of Oakland to the EBRCSA Board of Directors.
