RESOLUTION NO. 88082 C.M.S.

A RESOLUTION AMENDING CITY COUNCIL RESOLUTION NO. 87653 C.M.S. TO AUTHORIZE A THREE-YEAR CONTRACT EXTENSION WITH THE YOUTH EMPLOYMENT PARTNERSHIP TO IMPLEMENT TEAM OAKLAND PROGRAM FROM JUNE 30, 2020, TO JUNE 30, 2023, IN AN AMOUNT NOT TO EXCEED THREE HUNDRED SEVENTY-FIVE THOUSAND DOLLARS (\$375,000.00) PER YEAR AND WAIVE THE ADVERTISING AND PROPOSAL QUALIFICATIONS REQUIREMENT ASSOCIATED WITH SAID CONTRACT.

WHEREAS, Team Oakland is a citywide employment and environmental education opportunity program that provides for the training and education of youth and beautification services for the City that is managed by the City of Oakland, Public Works Department; and

WHEREAS, in 2019, the City Council approved Resolution No. 87653 C.M.S., authorizing the City Administrator to enter into an agreement with the Youth Employment Partnership (YEP), Inc. to hire, recruit and train persons needed to facilitate the Team Oakland program for a one-year program with an option to extend for one additional year upon satisfactory performance and Council approval; and

WHEREAS, YEP demonstrated higher than satisfactory performance for Fiscal Year 2019-2020 in managing teams of youth to work on a variety of environmental projects, including abatement of litter, illegal dumping, fire fuel reduction, weeds, and graffiti from public right of ways, and support for special events and volunteer groups to improve the quality of parks, creeks, natural areas, and open spaces; and

WHEREAS, YEP will continue to enhance Team Oakland effectiveness by strengthening the training and outreach components of the program to provide a transformative experience for the participating youth and to target underserved communities to promote City services; and

WHEREAS, this agreement advances City of Oakland racial equity outcomes through valuable job training and employment development for Oakland youth of color; and

WHEREAS, the City Council finds and determines that the performance of this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive services; and

WHEREAS, Oakland Municipal Code (OMC) Section 2.04.040.B.4 requires formal advertising and solicitation of proposals/qualifications for professional services contracts involving expenditures of more than \$50,000,00; and

WHEREAS, OMC Section 2.04.051.B allows for a waiver by the Council of these advertising and solicitation requirements upon a finding that it is in the best interests of the City to do so; now, therefore, be it

**RESOLVED:** That the Council hereby finds and determines per OMC Section 2.04.051.B that it is in the best interests of the City to waive the formal advertising and competitive selection requirement of OMC Section 2.04.040.B.4, and so waives the requirement, and to extend the contract with Youth Employment Partnership because of their demonstrated performance and ability to innovate while providing continuity and assurance to preserve the Team Oakland program and its summer youth jobs and training opportunities; and be it

**FURTHER RESOLVED:** That Resolution No. 87653 C.M.S. is amended to authorize a three-year contract extension with the Youth Employment Partnership to implement Team Oakland program from June 30, 2020, to June 30, 2023, in an amount not to exceed three hundred seventy-five thousand dollars (\$375,000.00) per year; and be it

**FURTHER RESOLVED:** That the City Administrator, or Designee, is authorized to execute said contract extension with the Youth Employment Partnership to hire, recruit and train persons needed to facilitate the Team Oakland program, subject to the review and approval of the City Attorney; and be it

**FURTHER RESOLVED:** That staff shall provide a contract performance update to Council on an annual basis; and be it

FURTHER RESOLVED: That all expenditures related to this proposed contract shall be allocated in Recycling Fund (1710), City Facilities (4400), and General Purpose Fund (1010); Environmental Services: Environmental Remediation Organization (30683); Services: Miscellaneous Contract Account (54919); Youth We Mean Clean Program Project (1001685); Environmental Compliance Project (1001642) and Sustainable Oakland Program (SC26); Litter Enforcement (30674): Contract Contingencies Account (54011); DP 300 Administrative Project (1000010); and Keep Oakland Clean and Beautiful Program (NB35); and be it

FURTHER RESOLVED: That proposed contract expenditure allocations for Fiscal Year 2020-2021, Fiscal Year 2021-2022 and Fiscal Year 2022-2023 will be contingent upon Council adoption of the budget; and be it

FURTHER RESOLVED: That the agreement and any amendments shall be reviewed and approved by the Office of the City Attorney for form and legality and placed on file in the Office of the City Clerk.
