**OAKLAND CITY COUNCIL**  
**RESOLUTION No. 88120 C.M.S.**

**A RESOLUTION APPROVING:**

1. (A) AWARDS OF GRANTS, (B) EXTENSIONS OF GRANT AGREEMENTS WITH EXISTING GRANTEEES, AND (C) AWARD OF A NEW GRANT TO RESTORATIVE JUSTICE FOR OAKLAND YOUTH, ALL FOR VIOLENCE INTERVENTION PROGRAMS FOR A TOTAL ESTIMATED AMOUNT OF \$8,197,500 FOR FISCAL YEAR 2020-2021; AND
2. AMENDMENTS TO THE AFOREMENTIONED GRANT AGREEMENTS, IF REVISED FISCAL YEAR 2020-2021 SAFETY AND SERVICES ACT REVENUE CHANGES EITHER POSITIVELY OR NEGATIVELY, WITHOUT RETURNING TO COUNCIL

**WHEREAS**, the City of Oakland voters passed Measure Z, the Oakland Public Safety and Services Violence Prevention Act ("Safety and Services Act"), in November 2014, approving a series of taxes to support violence intervention objectives, including programs and services that provide support for high-risk youth and young adults to interrupt the cycle of violence and recidivism; and

**WHEREAS**, the Human Services Department (HSD) administers Safety and Services Act funds for violence intervention programs and services through its Oakland Unite division, which every two-to-three years prepares a spending plan to outline the strategies and services recommended for the next funding cycle; and

**WHEREAS**, HSD's Oakland Unite division developed spending plan recommendations concerning strategies to prioritize and the process for allocating funds in collaboration with community and public partners that included community listening sessions, review of local and national best practices, and interviews with public and community partners; and

**WHEREAS**, the spending plan recommendations were informed by the ongoing citywide participatory planning process led by the Urban Strategies Council to inform the development of the City's new Department of Violence Prevention ("DVP"); and

**WHEREAS**, the violence prevention program strategies and the process for allocating funds for a two-year grant cycle were approved by City Council in December 2018 (via Resolution No. 87477 C.M.S.); and

**WHEREAS**, Oakland Unite staff issued a Request for Proposals in January 2019 and led a competitive process in which trained reviewers evaluated 53 eligible proposals requesting funding for violence prevention services and programs; and

**WHEREAS**, following the RFP process the City Council approved awards of violence prevention grant agreements from July 1, 2019 through June 30, 2020, pursuant to Resolution No. 87756 C.M.S.; and

**WHEREAS**, HSD contract monitoring activities found the majority of grantees to be in compliance with the terms of their awards, and staff recommends renewal for most previously-funded agencies from FY 2019-2020; and

**WHEREAS**, HSD will work closely with the program for whom renewed funding is contingent upon making improvements in certain areas identified during monitoring activities; and

**WHEREAS**, Restorative Justice for Oakland Youth (RJOY) has obtained 501(c)(3) status and will no longer be fiscally sponsored by Community Initiatives in FY 2020-2021, and therefore, approval of an award via a new approved grant agreement should be made by the City to RJOY directly; and

**WHEREAS**, staff recommends approving (1) the award of grants to, and authorizing execution of grant amendments to renew (*i.e.*, extend) grant agreements with, those service providers (other than RJOY) in the amounts specified in the below table and (2) the award of a grant to, and authorizing execution of a new grant agreement with, RJOY in the amount specified in the below table, all for a total estimated amount of \$8,197,500 from the period of July 1, 2020 through June 30, 2021, for the purpose of funding violence intervention services to high-risk youth and young adults; and

**WHEREAS**, the recommended awards will be supported primarily by \$6,058,137 included in the Mayor's proposed FY2020-2021 budget, pending City Council adoption, using restricted funds collected for violence prevention programs as authorized by the Safety and Services Act, and with \$1,581,200 available in Safety and Services Act FY 2015-2019 Carryforward Funds, in the Measure Z Fund (2252), Violence Prevention Administration (70111), DVP Projects (1004486-1004496 and 1004313), and \$558,163 one-time funds available due to receipt of delinquent payments under the Public Safety Act of 2004 Measure Y Fund (2251), Violence Prevention Administration (70111), Measure Y Reserve Project (1005042); now, therefore, be it

**RESOLVED:** That the City Council approves the (1) award of grants to, and authorizes execution of grant amendments to renew (*i.e.*, extend) grant agreements with, those service providers (other than RJOY) as specified in the below table and (2) award of a grant to, and authorizes execution of a new grant agreement with, RJOY in the amount specified in the below table, all for a total estimated amount of \$8,197,500 for the period of July 1, 2020 through June 30, 2021, to provide violence intervention services to high-risk youth and young adults;

**FURTHER RESOLVED:** That the funds for the majority of the recommended awards are included in the FY2019-2021 budget adopted by the City Council (as modified by the City midcycle budget) and will be supported by restricted funds collected for violence prevention programs as authorized by the Safety and Services Act, Fund (2252), Violence Prevention Administration (70111), DVP Projects (1004486-1004496 and

1004313), and one-time funds available due to receipt of delinquent payments under the Public Safety Act of 2004 Measure Y Fund (2251), Violence Prevention Administration (70111), Measure Y Reserve Project (1005042); and be it

**FURTHER RESOLVED:** That if revised Safety and Services Act revenue for Fiscal Year 2020-2021 changes further, either positively or negatively, HSD and/or DVP (by and through the City Administrator or his designee) may amend the aforementioned grant agreements to adjust the grant amounts during the 2020-2021 Fiscal Year, as limited by the total cumulative positive or negative funding change, without returning to Council; and be it

**FURTHER RESOLVED:** That any unexpended balances shall be placed into the Measure Z Reserve Fund (2252), Violence Prevention Administration (70111), and Violence Prevention Administration Measure Z Reserve Fund Project (1004313); and be it

**FURTHER RESOLVED:** That the City Administrator is hereby authorized to conduct all negotiations, execute and submit all documents, including but not limited to applications, agreements, amendments, modifications, payment requests and related actions which may be necessary for the above-referenced grant agreements, without increasing the amounts of the agreements, except as specified above; and be it

**FURTHER RESOLVED:** That said agreements and amendments shall be approved as to form and legality by the Office of the City Attorney and copies filed with the Office of the City Clerk.


