RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR OR HIS OR HER DESIGNEE TO AMEND FISCAL YEAR 2019-2020 CONTRACTS WITH THE SPANISH SPEAKING UNITY COUNCIL OF ALAMEDA COUNTY, INC., LAO FAMILY COMMUNITY DEVELOPMENT, INC., AND THE OAKLAND PRIVATE INDUSTRY COUNCIL FOR AN ADDITIONAL AMOUNT NOT TO EXCEED \$230,396.

**WHEREAS,** on July 2, 2019, the City Council approved Resolution No. 87759 C.M.S, the City of Oakland's Fiscal Year (FY) 2019-21 Biennial Budget, appropriating certain funds to provide for the expenditures proposed by said budget; and

WHEREAS, the City Council identified \$250,000 in funds in FY 2019-2020 and \$250,000 in FY 2020-21 for Workforce Training in the General Purpose Fund (1010), Workforce Investment Org (85311), DP850 Admin Project (1000019); and

WHEREAS, the Oakland Workforce Development Board (OWDB) has selected, through a competitive request for proposals process, the service providers (1) Spanish Speaking Unity Council of Alameda County, Inc., (2) Oakland Private Industry Council, and (3) Lao Family Community Development, Inc., to provide employment and training services to adults, dislocated workers, and businesses; and

WHEREAS, \$214,732 of the workforce training funds shall be allocated to the selected providers noted above to administer, through an amendment of their existing Fiscal Year 2019-2020 contracts, the training funds to support the Oakland Early Childhood Education Pathway Program and additional workforce training services in the following industry sectors: healthcare, information technology, transportation and logistics, advanced manufacturing, construction, public service, or hospitality; and

**WHEREAS**, \$35,268 of the workforce training funds have been allocated to support Oakland job seekers currently enrolled in workforce training programs; and

WHEREAS, training services must include one or more courses or classes, or a structured regimen, that upon successful completion lead to: (1) a certificate, associate degree; or (2) the skills or competencies needed for a targeted industry sector job, occupation, or skills identified for many types of jobs or occupations, as recognized by employers and determined prior to training; and

WHEREAS, Workforce Investment Opportunities Act (WIOA) requires states to identify economic regions within their states, and for local areas to coordinate planning and service delivery on a region; and

**WHEREAS**, the State of California designated the East Bay Regional Planning Unit (RPU) as four local workforce areas consisting of: Contra Costa County, the City of Richmond, Alameda County, and the City of Oakland; and

WHEREAS, the goal is to enable the East Bay RPU and its network of partners to be better positioned to provide high-quality services and value to key industry sectors and businesses while helping this same network be more responsive to, and engaged in, regional strategic priorities that include community based organizations, labor, educational organizations, and the public in general; and

WHEREAS, the East Bay RPU is fiscally supported by the four (4) Workforce Development Boards through WIOA formula funds, and the OWDB fiscal share is increased by \$15,664 for a total amount of \$20,000 for FY 2019-20; now, therefore, be it

**RESOLVED:** That the City Administrator or his or her designee is hereby authorized to amend the contracts of the workforce service providers listed above in the amount not to exceed \$230,396 for FY 2019-2020 to support (1) the Oakland ECE Pathway Program, (2) additional workforce training services specified above, and (3) OWDB fiscal share of the East Bay RPU; and be it

**FURTHER RESOLVED:** That the City Administrator or his or her designee is hereby authorized to transfer the General Purpose Funds (\$214,732) into projects TBD to be used past June 30, 2020; and be it

FURTHER RESOLVED: That the additional \$15,664 funds are hereby appropriated equally to the Workforce Development Fund (2195), Workforce Development Org (85311), Third Party Grant Contracts Earned Account (54912), OPIC East Bay Works Projects (1004967 – 1004970), and in Workforce Program (SC03); and be it
