INTRODUCED BY COUNCIL PRESIDENT PRO TEM DAN KALB

RESOLUTION AWARDING A GRANT IN AN AMOUNT NOT TO EXCEED \$4,500 FROM COUNCILMEMBER KALB'S GRAFFITI ABATEMENT MURAL AND GREEN WALL FUNDS TO ARTIST CAROLINE STERN FOR A MURAL ON THE OUTSIDE OF PIEDMONT GROCERY AT 4038 PIEDMONT AVENUE IN OAKLAND

WHEREAS, on June 27, 2013, the City Council adopted a budget that set aside graffiti abatement funds for murals and green walls for Oakland City Councilmembers to award at their discretion, subject to Council approval, in an effort to address graffiti within their districts; and

WHEREAS, the property at Piedmont Grocery at 4038 Piedmont Avenue in Oakland has a long wall in a highly visible location and a mural is intended to add to the neighborhood's growing collection of public art and to deter graffiti; and

WHEREAS, the owner of the property at 4038 Piedmont Avenue in Oakland, Roger Beardsley, and the owner of Piedmont Grocery, which occupies the property at 4038 Piedmont Avenue in Oakland both approve and support the proposed mural project; and

WHEREAS, Councilmember Kalb wishes to grant a portion of his graffiti Abatement Mural and Green Wall Funds to artist Caroline Stern for a mural on the property at Piedmont Grocery at 4038 Piedmont Avenue in Oakland; and

WHEREAS, in conformance with City requirements, artist Caroline Stern will provide documentation for the use of the Councilmember's Graffiti Abatement Mural and Green Wall funds, including any permits required and permission from the property owner to install the mural; now, therefore, be it

RESOLVED: That the City Council awards a grant in an amount not to exceed \$4,500 from Councilmember Kalb's Graffiti Abatement Mural and Green Wall Funds to artist Caroline Sternfor a mural on the property at Piedmont Grocery at 4038 Piedmont Avenue in Oakland; and be it

FURTHER RESOLVED: That the City Administrator is authorized to execute a grant agreement with the artist Caroline Stern for the above purpose, subject to approval as to form and legality by the City Attorney.
