INTRODUCED BY COUNCIL PRESIDENT PRO TEM DAN KALB, COUNCILMEMBER LYNETTE GIBSON MCELHANEY, COUNCILMEMBER LARRY REID AND COUNCILMEMBER LOREN TAYLOR

RESOLUTION IN SUPPORT OF ASSEMBLY BILL 3121 (WEBER) THAT WOULD ESTABLISH THE TASK FORCE TO STUDY AND DEVELOP REPARATION PROPOSALS FOR AFRICAN AMERICANS AND WOULD REQUIRE THE TASK FORCE TO (1) IDENTIFY, COMPILE, AND THE **SYNTHESIZE** RELEVANT CORPUS **OF EVIDENTIARY** DOCUMENTATION OF THE INSTITUTION OF SLAVERY THAT EXISTED WITHIN THE UNITED STATES AND THE COLONIES; (2) RECOMMEND THE FORM OF COMPENSATION THAT SHOULD BE AWARDED, THE INSTRUMENTALITIES THROUGH WHICH IT SHOULD BE AWARDED, AND WHO SHOULD BE ELIGIBLE FOR COMPENSATION; AND (3) SUBMIT A WRITTEN REPORT OF ITS RECOMMENDATIONS FINDINGS AND TO THE **STATE** LEGISLATURE;

WHEREAS, the State of California's municipal and state authorities actively supported Black enslavement in a variety of ways between 1850 and 1865; and

WHEREAS, slavery broadly impacted the conditions of African American life within California;

WHEREAS, the Civil Rights Movement ended the nation's most explicit forms of racism but neither redressed the centuries of inequity nor ended implicit and institutional forms of racial bias; and

WHEREAS, systemic state complicity in the construction of racial harm and inequity continued into the twentieth and twenty-first centuries; and

WHEREAS, implicit and institutional forms of racism, including the mass incarceration of African Americans, continues today; and

WHEREAS, Oakland, California was a critical destination for African American families migrating from the south in the 1940s; and

WHEREAS, the construction of freeways, train track, federal buildings, and redlining destroyed homes, tore neighborhoods apart, and embedded racial inequality and segregation into the city's development; and

WHEREAS, the percentage of African American residents make up Oakland's population has dropped from 50% in 1980 to 28% in 2010, and could be as low, or lower, than 16% in 2028 due partially to the extreme housing crisis plaguing the region; and

WHEREAS, the age of enslavement, in Oakland and more broadly the State of California and across the nation, birthed a legacy of racial harm and inequity that continues to impact the conditions of African American life in California; and

WHEREAS, Assembly Bill (AB) 3121 (Weber) would establish a Task Force to Study and Develop Reparation proposals for African Americans, with members appointed by the Governor, President Pro Tempore of the Senate and Speaker of the House; and

WHEREAS, Assembly Bill (AB) 3121 (Weber) would require the Task Force, consisting of eight appointed members, to compile and synthesize the prevailing historical record of Black slavery and its afterlives in California and across the United States; and

WHEREAS, Assembly Bill (AB) 3121 (Weber) would require the Task Force to recommend, among other things, the appropriate mechanisms for redress as it pertains to California's role in the enslavement of African Americans and its afterlives; now, therefore, be it

**RESOLVED:** That the Oakland City Council hereby endorses AB 3121 and urges the California State Legislature and Governor Gavin Newsom to support its enactment into law.

INTRODUCED BY COUNCIL PRESIDENT PRO TEMPORE DAN KALB, COUNCILMEMBER NOEL GALLO, AND CITY ATTORNEY BARBARA J. PARKER

RESOLUTION DIRECTING AND AUTHORIZING THE CITY ATTORNEY AND THE CITY ADMINISTRATOR TO TAKE ANY AND ALL LAWFUL NECESSARY STEPS TO PROTECT THE RIGHTS OF THE PEOPLE AND THE CITY OF OAKLAND AGAINST PRESIDENT DONALD TRUMP'S THREATS TO TAKE ACTIONS THAT RESULT IN HARM TO THE PEOPLE OF OAKLAND OR THE CITY OF OAKLAND, AND AGAINST ANY RELATED ACTIONS FEDERAL OFFICERS TAKE THAT RESULT IN HARM TO THE PEOPLE OF OAKLAND OR THE CITY OF OAKLAND

WHEREAS, on July 21, 2020, President Donald Trump threatened to send federal troops to Oakland and several other cities across the country allegedly in response to protests; and

WHEREAS, in Portland, Oregon, federal agents have attacked and tear-gassed peaceful protesters, and camouflage-clad federal agents were observed grabbing peaceful protesters and throwing them into unmarked vehicles; and

WHEREAS, this type of authoritarian violence has no place in Oakland or anywhere in our constitutional democracy; and

WHEREAS, the people of Oakland have a long and proud history of exercising First Amendment rights to assemble and speak individually and collectively on numerous important topics;

WHEREAS, the people of Oakland have regularly protested police brutality, racial injustice, and violations of the people's constitutional and civil rights; and

WHEREAS, the people of Oakland protesting for racial justice reform are voicing their legitimate, urgent, and grave concerns; and

WHEREAS, California Governor Newsom and Oakland Mayor Schaaf have both rejected a recent call by Donald Trump to send federal officers, such as officers from the Department of Homeland Security or the Department of Justice, to Oakland, and the Oakland Police Department has stated it would not want uninvited federal assistance to address crowd management in Oakland; and

WHEREAS, it remains the job and authority of the Oakland Police Department to protect public safety in Oakland; and

WHEREAS, Oakland is a beautiful, diverse city that values unencumbered freedom of speech and freedom of assembly for its people;

WHEREAS, it will harm Oakland if the federal government takes any action, including, but not limited to, action that encumbers the freedom of speech or freedom of assembly of its people, of its leaders, or of it as a local government; that threatens or attempts to threaten, intimidates or attempts to intimidate, or otherwise chills or discourages the exercise of Oaklanders' constitutional or civil rights; or that incites riots or violence; NOW THEREFORE BE IT

**RESOLVED:** That the City Council hereby directs and authorizes the City Attorney and the City Administrator to take any and all lawful necessary steps to protect the rights of the people and the City of Oakland against President Donald Trump's threats to take actions that result in harm to the people of Oakland or the City of Oakland, and against any related actions federal officers take that result in harm to the people of Oakland or the City of Oakland.
