AN ORDINANCE AMENDING THE SALARY SCHEDULE OF ORDINANCE NO. 12187 C.M.S. ("SALARY ORDINANCE") TO ADD THE FULL-TIME CLASSIFICATION OF RENT ADJUSTMENT PROGRAM MANAGER, ASSISTANT; TO ADD THE PART-TIME CLASSIFICATION OF TEMPORARY CONTRACT SERVICES EMPLOYEE, PT (SWORN); TO AMEND THE SALARY OF THE PART-TIME CLASSIFICATION OF TEMPORARY CONTRACT SERVICES EMPLOYEE, PT; TO AMEND THE SALARY OF THE FULL-TIME CLASSIFICATION OF TRAMPOREMENT PROGRAM; TO AMEND THE SALARY AND TITLE OF THE FULL-TIME CLASSIFICATION OF THE FULL-TIME CLASSIFICATION OF THE FULL-TIME CLASSIFICATION OF THE FULL-TIME CLASSIFICATION OF TOWESTMENT AND OPERATIONS MANAGER; AND TO AMEND THE SALARY OF THE CLASSIFICATION OF COUNCIL MEMBER TO ENSURE COMPLIANCE WITH THE OAKLAND PUBLIC ETHICS COMMISION'S CHARTER MANDATED SALARY ADJUSTMENT.

CHARTER MANDATED SALARY ADJUSTMENT.

This ordinance authorizes changes to the City's Classification Plan as shown in the City's Salary Schedule to add new classifications and amend existing classification titles and salary rates. Various departments are requesting new classifications to align with operational and service delivery needs; this applies to the new Rent Adjustment Program Manager, Assistant and Temporary Contract Services Employee, PT (Sworn) classifications. The pay rate of the existing Temporary Contract Services Employee, PT classification is being adjusted to ensure that the salary range is high enough to include the pay rate of potential future annuitants who serve temporarily in positions as high as City Administrator The pay rate for Manager, Capital Improvement Program is being adjusted to ensure a more appropriate salary differential and to avoid salary compaction with classifications that are next in line below it in the reporting structure. The job title for investment Officer is being adjusted to Investment and Operations Manager to reflect newly added duties, and the pay rate is being adjusted to compensate the classification for the newly added, higher level duties that better align with a manager level. Lastly, the pay rate for the Council Member classification is being increased to reflect the Oakland Public Ethic Commission's mandated salary increase in alignment with Section 202 of the Oakland City Charter and as authorized by Resolution No. 20-01 of the Oakland Public Ethics Commission.
