**NOTICE AND DIGEST**

**ORDINANCE AMENDING THE SALARY SCHEDULE OF ORDINANCE NO. 12187 C.M.S. ("SALARY ORDINANCE") TO ADD THE FULL-TIME CLASSIFICATION OF FIRE INSPECTION SUPERVISOR, TO ADD THE PERMANENT PART-TIME AND PART-TIME CLASSIFICATION EQUIVALENTS OF SPECIAL ASSISTANT TO THE MAYOR III, AND TO AMEND THE SALARY FOR DEPUTY CHIEF OF VIOLENCE PREVENTION.**

This ordinance authorizes changes to the City's Classification Plan as shown in the City's Salary Schedule to add new classifications and amend existing classification titles. The Oakland Fire Department is requesting a new supervisory classification to oversee fire inspection staff. The Mayor's Office is adding equivalent classifications at the Special Assistant to the Mayor III level to add greater flexibility for staffing. The salary for Deputy Chief of Violence Prevention is being amended to reflect five salary steps instead of a salary range with a minimum and maximum, which was listed incorrectly in a previous ordinance.
