

INTRODUCED BY COUNCILMEMBER _____

RESOLUTION AWARDING A CONSTRUCTION CONTRACT TO NOR-CAL PIPELINE SERVICES, INC., THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, IN ACCORDANCE WITH PROJECT SPECIFICATIONS FOR ON-CALL SANITARY SEWER ROOT FOAMING SERVICE FY 2019-22 (PROJECT NO. 1000835) AND WITH CONTRACTOR'S BID IN THE AMOUNT OF ONE MILLION NINE HUNDRED TWENTY-TWO THOUSAND THREE HUNDRED TWENTY-ONE DOLLARS AND THIRTY-FIVE CENTS (\$1,922,321.35)

WHEREAS, on May 14, 2020, three bids were received by the Office of the City Clerk of the City of Oakland for On-Call Sanitary Sewer Root Foaming Service FY 2019-22 (Project No. 1000835); and

WHEREAS, Nor-Cal Pipeline Services, Inc., is deemed the lowest responsive and responsible bidder for the project; and

WHEREAS, there is sufficient funding for this project and is available in the Adopted FY 2019-21 Capital Improvement Program Budget in the Sewer Service Fund (3100), Sanitary Sewer Design Organization (92244), and Sanitary Sewer Root Foaming Project (1000835); and

WHEREAS, the City Council finds and determines based on the representations set forth in the City Administrator's report accompanying this Resolution that the construction contract approved hereunder is temporary in nature; and

WHEREAS, the City lacks the equipment and qualified personnel to perform the necessary work, that the performance of this contract is in the public interest because of economy or better performance and that this contract is of a professional, scientific or technical nature; and

WHEREAS, Nor-Cal Pipeline Services, Inc. complies with all LBE/SLBE and trucking requirements; and

WHEREAS, the City Council finds and determines that the performance of this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive service; now, therefore, be it

RESOLVED: That the City Administrator is authorized to award a construction contract for the Sanitary Sewer Root Foaming FY 2019-22 (Project No. 1000835) to Nor-Cal Pipeline Services, Inc., the lowest responsive and responsible bidder, in an amount of One Million Nine Hundred Twenty-Two Thousand Three Hundred Twenty-Two Dollars And Thirty-Five Cents (\$1,922,321.35) for project 1000835 and in accordance with plans and specifications for the Project and contractor's bid dated May 14, 2020; and be it

FURTHER RESOLVED: That the amount of the bond for faithful performance bond, \$1,922,321.35, and the bond to guarantee payment of all claims for labor and materials furnished and for the amount under the Unemployment Insurance Act, \$1,922,321.35, with respect to such work are hereby approved; and be it

FURTHER RESOLVED: That the City Administrator, or designee, is hereby authorized to enter into a contract with Nor-Cal Pipeline Services, Inc. on behalf of the City of Oakland and to execute any amendments or modifications of the contract within the limitations of the project specifications; and be it

FURTHER RESOLVED: That the City Administrator, or designee, is hereby authorized to negotiate with the second lowest bidder for the same awarded amount, if Nor-Cal Pipeline Services, Inc. fails to return the complete signed contract documents and supporting documents within the days specified in the Special Provision without going back to City Council; and be it

FURTHER RESOLVED: That the plans and specifications prepared for this project, including any subsequent changes during construction, that will be reviewed and adopted by the Director, or designee, are hereby approved; and be it

FURTHER RESOLVED: That the contract shall be reviewed and approved by the City Attorney for form and legality prior to execution and placed on file in the Office of the City Clerk.


