Please tell us how your qualifications and participation will relate to the requested board and/or commission's mission.

My unique qualifications for this role arise primarily from 1) my ongoing service as a member of the Library Commission, 2) my previous service as a member of the Youth Leadership Council, the city-wide teen advisory board for the Oakland Library System, 3) my public policy analysis skills from my current work experience as well as undergraduate and graduate education in Public Policy, and 4) my familiarity with Oakland's government and people from my previous work experience. During my current service on the Library Advisory Commission, I have contributed to the group's work in several ways. First, I have been deeply involved in supporting the work of the Friends of the Piedmont Avenue Branch Library as they seek to secure a permanent home for their branch. I have also represented the interests of the Library Commission in discussions about the Downtown Oakland Specific plan and its impacts on library services. I further served as a liaison to the branch friends group at the Montclair Library, keeping them informed on broader city-wide issues. In addition to these specific projects, I have been an active participant in Library Commission discussions on a variety of topics and co-hosted the annual library celebration in 2019. Prior to this service, I was a member of the Youth Leadership Council for roughly three years, from when I was a sophomore in high school until shortly after graduation. While I was a member of this group, I helped advise the library on youth engagement, engage with elected officials, and plan what is now a recurring annual library event (Culture Fest). The experience helped me gain a broad understanding of the work and organization of Oakland's library system and an even greater appreciation of the critical work our librarians do every day. The education I received while I earned graduate and undergraduate degrees in Public Policy will also likely be useful, as will my ongoing work for the County of San Mateo. Among the many topics included in my education were how to evaluate and interpret studies on the impacts of specific public policies, how to compile, analyze, and explain statistical information, how to fully examine the costs and benefits of an action, and the influence of politics on policymaking. My work for the County of San Mateo is primarily about public policy analysis and community engagement around affordable housing and homelessness. Through this work, I have conducted extensive public engagement in public meetings, small group presentations, and individual discussions with stakeholders and ordinary residents. This experience listening and engaging with the public will be helpful in ensuring I successfully bring the community's priorities to the Library Commission. My policy analysis work has also provided valuable experience in researching best practices and making projections for demands on public services. Finally, as an Oakland native, and as someone who has spent three summers interning in Oakland city government and has been significantly involved in two Oakland political campaigns, I have had the opportunity to engage directly with residents from across Oakland and listen to their aspirations for city government. I have always believed that the library system is not just a place where people find books (as critical a function as that is), it is an opportunity for residents to access a broad variety of services and resources that address many of our city's most pressing challenges. The library system already has a plethora of services and opportunities available, from the tool lending library to college application resources to lawyers in the library and beyond. If I am fortunate enough to be able to continue toserve on the Library Advisory Commission, I will remember the hopes and fears that have been expressed to me these past several years and continually search for new ways the library can help respond to them.
