I believe we are there on the actual amendments and the only thing missing is the Settlement and Release that the City was to provide back in April. Does the City has a form Settlement & Release agreement and I will prepare the document for the City's review?

Ultimately this cannot continue to drag out. So unless I receive a response from the City by Friday, September 4 at 5pm PST, I will assume that the City no longer wishes to settle the matter and will proceed with filing a request for declaratory relief.
