RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR OR DESIGNEE TO ACCEPT AND APPROPRIATE THE FISCAL YEAR (FY) 2020 U.S DEPARTMENT OF JUSTICE "CORONAVIRUS EMERGENCY SUPPLEMENTAL FUND" GRANT IN THE AMOUNT OF ONE MILLION THREE HUNDRED THIRTY THOUSAND FIVE HUNDRED EIGHTY-TWO DOLLARS (\$1,330,582), TO PURCHASE: 1) COMMUNITY RESOURCE SAFETY VEHICLES (CRVS); 2) A DECONTAMINATION TRAILER; AND 3) PERSONAL PROTECTIVE EQUIPMENT (PPE) AND SANITATION SUPPLIES DURING THE GRANT PERIOD OF JANUARY 20, 2020 THROUGH JANUARY 31, 2022

WHEREAS, the U.S. Department of Justice (DOJ), Office of Justice Programs, FY 2020 Coronavirus Emergency Supplemental Funding (CESF) awarded the City of Oakland Police Department (OPD) grant funds in the amount of \$1,330,582 during the grant period of January 20, 2020 to January 31, 2022; and

WHEREAS, the purpose of the CESF Program is to provide funding to help local agencies in preventing, preparing for, and responding to the Coronavirus Covid-19 Pandemic; and

WHEREAS, the DOJ CESF grant rules prohibit grantees from supplanting state or local funds, and must use grant funds to increase otherwise available program funding; now, therefore, be it

RESOLVED: that the City Council hereby authorizes the City Administrator or designee to accept and appropriate the FY 2020 U.S DOJ Coronavirus Emergency Supplemental Fund (CESF) Grant Allocation in the amount of one million three hundred thirty thousand five hundred eighty two dollars (\$1,330,582), to purchase mobile command vehicles, a decontamination trailer, and personal protective equipment, over the course of the grant period of January 20, 2020 through January 31, 2022; and be it

FURTHER RESOLVED: that the City Council hereby authorizes the City Administrator, or designee, to accept a no-cost grant extension for up to one year if needed; and be it

FUTHER RESOLVED: That the City Council authorizes OPD to spend funds in accordance with the spending plan outlined above as well as in the report accompanying this resolution to purchase mobile command vehicles, a decontamination trailer, and personal protective equipment; and be it

FURTHER RESOLVED: That grant funds will be appropriated to Federal Grant Fund (2112); Fiscal Services Division Org. (106510); Agency-wide Administration (PS01), in a Project and Account to be determined; and be it

FURTHER RESOLVED: That grant funds received for the CESF program shall not be used to supplant expenditures controlled by the City of Oakland; and be it

FURTHER RESOLVED: That the City Administrator, or designee, is hereby authorized to complete all required negotiations, certifications, assurances and documentation required to accept, modify, extend and/or amend the agreement.

FURTHER RESOLVED: that all contracts issued hereunder shall be reviewed and approved by the City Attorney for form and legality and copies shall be placed on file in the City Clerk's Office.
