## **RECOMMENDATION**

Staff Recommends That The City Council Adopt A Resolution Authorizing The City Administrator, Or Designee, To Accept and Appropriate The Fiscal Year 2020 State Of California "Citizens Options For Public Safety" (State COPS Grant XXIII) Allocation In The Amount Of Six Hundred Fifty-Eight Thousand Eight Hundred Twenty Dollars (\$658,820) Plus Accrued Interest Earnings, Of Up To Ten Thousand Dollars For A Total Amount Not To Exceed Six Hundred Sixty-Eight Thousand Eight Hundred Twenty Dollars (\$668,820), To Fund Helicopter Maintenance, Computer And Technology Upgrades, And Stop Sticks For Patrol Cars.

## **EXECUTIVE SUMMARY**

The Oakland Police Department (OPD) has been awarded \$658,820 plus approximately \$10,000 in accrued interest by the State of California Legislature for the Fiscal Year (FY) 2020 Citizens' Option for Public Safety (State COPS Grant XXIII). State COPS Grant funds are distributed to each county for distribution to cities to support front-line law enforcement, based on a population size distribution formula. OPD is seeking approval to use its front-line law enforcement grant allocation to fund helicopter maintenance, invest in computer and technology upgrades, and to purchase stop sticks.

## **BACKGROUND / LEGISLATIVE HISTORY**

For the 23<sup>rd</sup> consecutive year, the State Legislature has authorized supplemental funding of front-line law enforcement through the State COPS and Juvenile Justice Crime Prevention Act (JJCPA) Grant program. In 2020, 50 percent of the grant funds are allocated to counties to spend on juvenile justice work, 39.7 percent of grant funds are separately allocated to cities for front-line law enforcement (this OPD COPS Grant), and 10.3 percent of funds are allocated to county sheriffs and district attorneys (see *Attachment A* for the Award Letter Grant Allocation List).

As in past years, the entire 2020 grant amount and accrued interest is restricted by statute for frontline law enforcement expenses. Examples of 'frontline law enforcement' include personnel and equipment (e.g. officer training, vehicles, officer equipment), which are utilized in everyday

contact with the public. OPD has used past State COPS grant funds for a variety of allowed uses, such as:

- Vehicle purchases and upgrades;
- Anti-human trafficking operations (personnel);
- Ceasefire operations (personnel);
- Equipment and equipment maintenance;
- · Software and technology upgrades; and
- Other personnel and training needs.

The grant program is a supplemental funding source for local governments. There is no guarantee that this grant will be continued by the State of California Legislature in future years. The COPS legislation, Assembly Bill (AB) 1913 requires that funds are received by the Alameda County Treasury and distributed to local jurisdictions through the Law Enforcement Services Account within the Local Revenue Fund 2011.

In the past five years, the City Council has approved several resolutions to accept and appropriate State COPS Grants: Grant XXII via Resolution No. 87938 C.M.S., Grant XXI via Resolution No. 87819 C.M.S., Grant XX via Resolution No. 86530 C.M.S., and Grant XVIII via Resolution No. 86313 C.M.S.

## **ANALYSIS AND POLICY ALTERNATIVES**

The Oakland Police Department is seeking City Council approval to accept and appropriate State COPS XXIII funds per the spending plan below.

Helicopter Repairs/Maintenance: \$250,000

Funds will be used to fund much-needed ongoing helicopter maintenance for OPD's helicopter which is over 25 years old and requires frequent maintenance and repairs exceeding the current allocation from the General-Purpose Fund. This use of funds was identified in the report that supported the recent helicopter maintenance contract approval (CMS 88173).

Computer and Technology Upgrades: \$358,820

Funds will be used for various needed technology upgrades, including the purchase of new computers, software, licenses, and other needed hardware for OPD staff. These funds are necessary to augment general fund support for the department's use of technology.

Stop Sticks: \$50,000

Funds will be used to purchase high speed pursuit tire-deflation device ("stop sticks") for patrol cars. These devices can be thrown into the road in advance of a fleeing vehicle to deflate the vehicle tires and terminate a pursuit; the devices look like long triangular prisms (long enough to reach both tires of an average vehicle) and contain small internal spikes which can puncture vehicle tires and slowly deflate them. Stop Sticks can also be used to end pursuits (stop vehicles by puncturing the tires) or to stop a pursuit from occurring - setting the Stop Stick in a

stationary location of a suspect's vehicle so that the suspect cannot drive away without running over the device.

# **FISCAL IMPACT**

OPD seeks to use its \$658,820 State COPS XXIII allocation to fund helicopter maintenance and invest in new equipment, as detailed below. There is no match requirement for this grant. The appropriation is solely an addition to City funds and cannot be used to supplant City funding from any other fund.
