WHEREAS, Superior Court of the State of California, County of Alameda, Case No. RG19022470, was filed against the City of Oakland, alleging a claim for dangerous condition on public property; and

WHEREAS, the City has considered all the evidence, litigation costs, and litigation risks in this case; and

WHEREAS, the City admits no wrongdoing or liability; now, therefore be it

**RESOLVED:** That the City Attorney is authorized and directed to compromise and settle the case of Rebecca Reed-Lunn v. City of Oakland, City of Oakland Public Works, County of Alameda and Does 1-50, Alameda County Superior Court Case No. RG19022470, City Attorney's File No. 33115, for the sum of Ninety Eight Thousand Nine Hundred Ninety Nine Dollars and Zero Cents (\$98,999.00); and be it
