**WHEREAS,** the date March 16, 2021 and the time 1:30 p.m., was fixed as the day and hour of the public hearing for the Council to hear the reports concerning delinquent trash service fees with added administrative and special assessment charges, and any protests or objections to said reports; now, therefore be it

**RESOLVED:** That the protests are hereby overruled; and be it
