2019/20 CONSOLIDATED ANNUAL PERFORMANCE & EVALUATION REPORT SUMMARY

The City of Oakland receives annual federal grant funding under the United States Department of Housing & Urban Development (HUD) Community Planning and Development (CPD) programs: Community Development Block Grant (CDBG), HOME Investments Partnership, Emergency Solutions Grant (ESG) and Housing Opportunities for Persons with AIDS (HOPWA) Programs.

The Consolidated Annual Performance and Evaluation Report (CAPER) for program year 2019/20 reports the City's accomplishments and progress towards meeting goals set forth in the 2019/20 Annual Action Plan (AAP) for production, preservation and protection of affordable housing; economic development activities, public services; public facility improvements; homeless services; and HIV/AIDS housing and services set forth in the 2019/20 AAP for the period of July 1, 2019 through June 30, 2020.

\$13,964,586 awarded to the City under the 2019/20 CDBG, HOME, HOPWA and ESG programs was allocated along with other match and leverage funds to support the following activities:

- 1. Accessibility, availability and sustainability of decent affordable housing,
- 2. Accessibility, availability and sustainability of suitable living environments,
- 3. Accessibility, availability and sustainability of economic opportunities,
- 4. Accessibility, availability and sustainability of public services to low- and moderate income residents of Oakland,
- 5. Rapid re-housing and other assistance to decrease episodes of homeless; and
- 6. AIDS housing and services for people living with AIDS and their families.

The following is a summary of accomplishments included in the City's 2019/20 CAPER for activities funded under the CDBG, HOME, HOPWA, and ESG.

Hunger & Homeless Solutions

Approximately 5,500 extremely low-, low- and moderate-income residents of Oakland received food services (hot meals and brown bag food distributions) under the Hunger Program. Rapid re-housing assistance and shelter was provided to over 1,900 homeless individuals. One hundred seventy-seven persons exited homelessness into permanent or transitional housing. Thirteen units of HIV/AIDS housing were added; 222 people living with HIV/AIDS (PLWA) received Short Term Rental Mortgage Utility (STRMU) and other subsidy assistance; 27 PLWA received permanent housing placements. Supportive Housing and services were provided to 440 family and single households. Maintained inventory or transitional and emergency housing through acquisition assistance of two facilities.

Affordable Housing

10 Oakland households received financial assistance to purchase their first home through the First Time Home Buyer Mortgage Assistance Program. Acquired 7 units of affordable housing; completed construction of 152 units, started construction of 114 units, and completed predevelopment for 124 units, closed financing for 116 units to be developed for extremely low- and very low-income families, and committed financing for another 91 units of affordable housing.:

Economic Development

In program year 2019/20, 153 businesses and construction workers received technical assistance, planning and development assistance, training, or direct financial assistance through economic development activities. In addition, 1,452 businesses participated in an online business directory promoting East Oakland businesses.
