RESOLUTION NO. 88424 C.M.S.

RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR, OR DESIGNEE, TO ACCEPT AND APPROPRIATE GRANT FUNDS TO THE OAKLAND POLICE DEPARTMENT (OPD) IN AN AMOUNT NOT TO EXCEED THREE HUNDRED TWENTY-FIVE THOUSAND DOLLARS (\$325,000), FROM THE DEPARTMENT OF HOMELAND SECURITY (DHS), FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA) FOR THE PORT SECURITY GRANT PROGRAM (PSGP) DURING THE THREE YEAR GRANT PERIOD OF SEPTEMBER 1, 2020 – AUGUST 31, 2023, TO PURCHASE A ZODIAC SRA900 WATERCRAFT AND TO AUTHORIZE OPD TO PROVIDE THE REQUIRED TWENTY FIVE PERCENT (25%) IN-KIND MATCH OF ONE HUNDRED EIGHT THOUSAND THREE HUNDRED THIRTY FOUR DOLLARS (\$108,334).

WHEREAS, the Marine Unit of OPD is the City's designated regulator of waterway security in and around the City of Oakland; and

WHEREAS, members of the Marine Enforcement Unit are tasked with security of the ports and waterways of the Port of Oakland and Oakland International Airport estuary and waterside areas; and

WHEREAS, OPD applied for and was awarded a three-year grant of three hundred twenty-five thousand dollars (\$325,000) from the Department of Homeland Security (DHS), Federal Emergency Management Agency (FEMA) for the Port Security Grant Program (PSGP) to improve transportation infrastructure and port security risks against terrorism attacks; and

WHEREAS, the grant funds will be used to purchase a Zodiac SRA900 watercraft to replace OPD's currently aging primary vessel; and

WHEREAS, the City Council previously approved acceptance and appropriation of the PSGP grant via Resolution No. 87969 C.M.S., dated December 10, 2019, and

WHEREAS, the 2020 PSGP grant award period of performance is September 1, 2020 – August 31, 2023; and

WHEREAS, the PSGP requires a twenty-five percent (25%) match that OPD plans to meet via in-kind personnel time related to training staff on how to use the boat and general maintenance and upkeep; therefore be it

RESOLVED: That the City Council does hereby authorize the City Administrator or designee to accept and appropriate a grant award to OPD in the amount of three hundred twenty-five thousand dollars (\$325,000) from DHS/FEMA; and be it

FURTHER RESOLVED: That the grant funds shall be maintained in the FEMA fund (2124), Special Operations organization (107710), Marine Unit (PS13) in the Project to be determined; and be it

FURTHER RESOLVED: That the City Council hereby authorizes the City Administrator or designee to act as an agent to conduct all negotiations and related actions and to sign all applications and agreements that may be necessary for the completion of the aforementioned grant.
