RESOLUTION 1) AUTHORIZING THE CITY ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH CITY OF EMERYVILLE TO RECEIVE FOUR HUNDRED EIGHTY THOUSAND DOLLARS (\$480,000) TO PROVIDE OAKLAND PUBLIC LIBRARY SERVICES TO EMERYVILLE RESIDENTS FOR FISCAL YEARS 2019-20, 2020-21, 2021-2022, AND 2022-23, AND 2) ACCEPTING AND APPROPRIATING SAID FUNDS

**WHEREAS,** Emeryville residents receive library services from Oakland Public Library; and

WHEREAS, the last agreement between the cities was for the ten-year period from 1998 through 2008; and

WHEREAS, there is no revenue to City of Oakland without an agreement; and

WHEREAS, Emeryville will pay the City of Oakland \$120,000 for fiscal year 2019-20, and \$120,000 for fiscal year 2020-21, and \$120,000 for fiscal year 2021-22, and \$120,000 for fiscal year 2022-2023; and

WHEREAS, the revenue received shall be deposited into the City of Oakland General Purpose Fund (1010) in project number 1000013; and

WHEREAS, section 504 of the Oakland City Charter provides that the City Administrator may negotiate contracts for joint governmental actions, subject to Council approval; now, therefore, be it

**RESOLVED:** That the City Administrator is hereby authorized to enter into an agreement with the City of Emeryville whereby Emeryville will provide the City \$120,000 each fiscal year for fiscal years 2019-20, 2020-21, 2021-22, and 2022-2023 for a total amount of \$480,000 in order for the City to provide Oakland Public Library services to Emeryville residents; and be it

**FURTHER RESOLVED:** That the City Council hereby accepts \$480,000 from the City of Emeryville and appropriates said funds in General Purpose Fund (1010), Library Administrative Project (1000013).
