RESOLUTION AMENDING RESOLUTION NO. 88174 C.M.S., WHICH ADOPTED THE FISCAL YEAR 2020-21 MID-CYCLE BUDGET ADJUSTMENTS, TO 1) UNFREEZE POSITIONS FUNDED BY THE DEVELOPMENT SERVICES FUND (FUND 2415); 2) APPROPRIATE TWO MILLION FOUR HUNDRED FIFTY THOUSAND TWO HUNDRED SEVENTY-NINE DOLLARS (\$2,450,279) FROM FUND 2415 FUND BALANCE TO FUND THE UNFROZEN POSITIONS; AND 3) TO APPROPRIATE ONE HUNDRED SIXTY THOUSAND DOLLARS (\$160,000) FROM THE PENALTY REVENUE IN FUND 2415 FUND BALANCE TO CREATE A 1.0 FULL TIME EQUIVALENT (FTE) HUMAN RESOURCES ANALYST POSITION IN THE HUMAN RESOURCES DEPARTMENT TO EXPEDITE HIRING TO FILL POSITIONS FUNDED BY FUND 2415

WHEREAS, the Council created the Development Services Fund (Fund 2415) by ordinance in 2006 (City Ordinance No. 12741 C.M.S.) to account for the revenues and expenditures related to development and enforcement activities in the City of Oakland; and

WHEREAS, pursuant to Ordinance No. 12741, the revenue source for Fund 2415 is fees and penalties identified in the Planning and Building section of Oakland's Master Fee Schedule ("MFS"), except for fees that have been specifically excluded from Fund 2415 by Ordinance No. 12741 C.M.S and other actions of the Council; and

WHEREAS, in accordance with State and City laws, the revenue from fees in Fund 2415 is used only to pay for expenditures related to the direct and indirect costs of the City's development and enforcement activities; and

WHEREAS, such direct and indirect costs include positions across all departments of the City supporting its development and enforcement activities; and

WHEREAS, pursuant to Resolution No. 88174 C.M.S., which adopted the fiscal year 2020-21 mid-cycle budget adjustments, many positions throughout the City were frozen to address the City's fiscal crisis; and

WHEREAS, positions supporting the City's development and enforcement activities funded through Fund 2415 were mistakenly frozen during the mid-cycle budget adjustment process; and

**WHEREAS**, these positions are necessary to perform the City's development and enforcement activities and need to be unfrozen and filled expeditiously; and

**WHEREAS**, adding a 1.0 Full Time Equivalent (FTE) Human Resources Analyst position in the Human Resources Department will expedite hiring to fill positions in Fund 2415; and

**WHEREAS**, Fund 2415 receives between \$300,000 and \$500,000 in unrestricted penalty revenue annually, which is available to fund the new 1.0 FTE Human Resources Analyst position; now, therefore, be it

**RESOLVED:** That the City Council amends Resolution No. 88174 C.M.S., which adopted the Fiscal Year 2020-21 mid-cycle budget adjustments, to unfreeze the positions in **Table 1** below that were mistakenly frozen during the mid-cycle budget adjustment process

**FURTHER RESOLVED:** That the City Council amends Resolution No. 88174 C.M.S., which adopted the Fiscal Year 2020-21 mid-cycle budget adjustments, to appropriate One Hundred Sixty Thousand Dollars (\$160,000) from the penalty revenue in Fund 2415 fund balance to create a 1.0 Full Time Equivalent (FTE) Human Resources Analyst position in the Human Resources Department to expedite hiring to fill positions in Fund 2415.


