Project work includes wrapping carbon fiber reinforced polymer (CFRP) around concrete members; applying a mortared finish over the CFRP wrap; application of localized shotcrete; removal and replacement of existing AC overlay with a polyester concrete overlay; removal of graffiti paint; patching of spalled concrete; and repair or replacement of the existing chain link fence. In the City of Oakland, county of Alameda, this affects your facilities: 16" gas line as shown on the attached Owner's Installation plan (PM #35147842) pages 1-2, dated 3/9/2020, also called out on Agency's U-1 and U-2 sheets, dated 8/21/2020.
