I am an elected California Democratic Party Assembly District Delegate and a Program Officer of Policy and Innovation at the San Francisco Foundation. Early in my professional journey, I have had the privilege of serving in critical roles on the frontlines of progressive change in California and across the nation. Driven by a passion for racial, economic and housing justice, I have served on several boards and committees including, the Regional Housing Needs Allocation (RHNA) Housing Methodology Committee at the Association of Bay Area Governments, as well as the One Bay Area Grant Program/Priority Development Area Technical Advisory Committee (TAC) and the Regional Transit Oriented Development TAC at the Metropolitan Transportation Commission. My work includes advising regional housing planning staff and elected officials throughout the Bay Area on regional policy, programs, and strategies that preserve and expedite production of affordable housing, protect tenants, advance racial justice and economic equity, and proactively address historical patterns of racial exclusion and segregation. I have also served on the boards of several non-profit organizations rooted in millennial civic engagement including the East Bay Stonewall Democratic Club, the Black Young Democrats of Sacramento, and the California Young Democrats Black Caucus. As a passionate social justice advocate, I have volunteered on numerous local, state, and federal campaigns for Democratic leaders. I was a 2020 New Leaders Council (NLC) Oakland Fellow and now serve on the Board of Directors for both NLC Oakland and the Greenlining Institute Academy Alumni Association, where my focus includes leadership and professional development and digital organizing and communications. I was recently appointed to the Regional Planning Committee at the Association of Bay Area Governments. Additionally, I am the Founder of R&N Strategies, LLC, a political consulting firm focused on identifying, recruiting, and advising progressive grassroots candidates for local elected offices in the Bay Area. He is a 2009 graduate of the inaugural class at the University of California, Merced, a 2011 graduate of the Ralph J. Bunche Center for African-American Studies at UCLA, and a 2016 graduate of the University of California, Hastings College of the Law, where he earned a certificate in Social Justice Lawyering. Rodney is a native of Portsmouth, Virginia and currently resides in Oakland, California. Early in my professional journey, I have had the privilege of serving in critical roles on the frontlines of progressive change. Some of the highlights of my public interest career include serving as a Public Policy and Networks Associate in Washington, D.C. at the National Black Justice Coalition in 2011, where I was instrumental in the marriage equality campaign in Prince George's County, Maryland. In 2012, Maryland made United States history as the first state in the country to approve marriage equality at the ballot box for same-sex couples. After graduating from law school, I worked at Public Advocates, a leading San Francisco Bay Area non-profit civil rights law firm and social justice advocacy organization that challenges the systemic causes of poverty and racial discrimination by strengthening community voices in public policy and achieving tangible legal victories advancing education, housing and transit equity. I have also served as a Law Clerk at the California Department of Justice in the Office of the Attorney General and worked at the Greenlining Institute, a progressive policy, research, organizing, and leadership development institute in Oakland, working for racial and economic justice. My most recent accomplishments, include participation in the Equality California Institute's Northern California Leadership Academy in 2017, service at the California State Senate and at the Democratic Party of Georgia, as part of their historic coordinated campaign in 2018, which sought to elect Leader Stacey Abrams as the country's first Black woman Governor. I have served on the boards of the East Bay Stonewall Democratic Club, the Black Young Democrats of Sacramento, and the California Young Democrats Black Caucus and volunteered on numerous local, state, and federal campaigns for progressive leaders. I currently serve on the board of the Greenlining Academy Alumni Association. In 2015, NBJC named me one of the 100 Black LGBTQ/SGL Emerging Leaders to Watch.
