RECOMMENDATION

Staff Recommends That The City Council Approve A Resolution (1) Authorizing A Memorandum Of Understanding With The County Of Alameda For City To Receive Funds In An Amount Not To Exceed \$778,549 As Reimbursement For Providing COVID-19 Testing Services, And (2) Appropriating Said Funds, And (3) Awarding A Pass-Through Grant Agreement In An Amount Not To Exceed \$73,474 To La Clinica De La Raza As Reimbursement For Providing COVID-19 Testing Services.

EXECUTIVE SUMMARY

The City of Oakland partnered with Alameda County and community-based organizations to provide COVID-19 testing services during the first nine months of the global pandemic.

Approval of this Memorandum of Understanding (MOU) will allow the City to receive reimbursement for a variety of testing expenses that were incurred and paid in calendar year 2020. Most of these expenses would not be available for reimbursement through other sources.

BACKGROUND / LEGISLATIVE HISTORY

In December 2019, an outbreak of a respiratory illness due to a novel coronavirus (a disease known as 2019 Novel Coronavirus or COVID-19) was first identified in Wuhan City, Hubei Province, China. On January 23, 2020, the federal Centers for Disease Control and Prevention (CDC) activated its Emergency Response System to provide ongoing support for the response to COVID-19 across the United States. In addition, the Secretary of the US Department of Health and Human Services declared a public health emergency in the United States on January 31, 2020. In Alameda County, the Board of Supervisors adopted a resolution ratifying the declaration of a local health emergency by the County Health Officer on March 10, 2020.

In Oakland, City Council adopted Resolution 88075 C.M.S. on March 12, 2020 ratifying the declaration of a local emergency by the City Administrator acting as the Director of the Emergency Services Operation Center on March 9, 2020.

ANALYSIS AND POLICY ALTERNATIVES

According to the CDC, testing for individuals who are at high risk for contracting the virus is an important strategy to reduce community transmission of COVID-19. To support efforts by cities to expand testing services, Alameda County adopted the Alameda County & City COVID-19 Testing Partnership Framework on June 30, 2020 to coordinate resources and provide technical assistance to cities to increase equitable access to testing and lab processing services for residents most impacted by COVID-19.

With the support of the newly established Community Resilience Branch in the City's Emergency Operation Center, Oakland partnered with Alameda County and community-based organizations to provide free COVID-19 testing at several sites during the height of the pandemic. These services were intended to alleviate pressure on hospital emergency rooms; provide quicker answers for recently exposed first responders, health care workers, and persons with recent suspected exposures to COVID-19; ensure equitable access for communities most impacted by racial disparities; and enhance the region's capacity to suppress new transmissions through isolation after testing. In addition to such community-based testing the City also offered testing to first responders and other essential workers during this period, which will also be eligible for reimbursement by the County.

Expenses subject to reimbursement under the MOU include \$146,589 incurred by the City for testing site sanitation and security, \$434,707 for testing of first responders, essential workers and individuals in high risk populations, and \$73,474 to be passed through to La Clinica de La Raza for expenses incurred in excess of donations received for testing site personnel and equipment rentals. Although the MOU provides for reimbursements not to exceed \$778,549, the City estimates that eligible costs under the agreement will fall below this level and total \$654,770.

Testing site expenses for the City and La Clinica de La Raza may be eligible for reimbursement by the Federal Emergency Management Agency (FEMA). Such reimbursements would be subject to a 25% local cost share, significantly more burdensome documentation requirements, and uncertainty regarding the timing of payments. Testing expenses for first responders and other essential personnel may not be eligible under any FEMA program. The City chose to work with Alameda County on this agreement to simplify the reimbursement process, accelerate the timeline for payment, and gain reimbursement for expenses that would not otherwise be available.

FISCAL IMPACT

Approval of this MOU will allow the County to apply for direct payment by Alameda County to the City of \$654,770, of which \$73,474 would be passed through to La Clinica de la Raza.

PUBLIC OUTREACH / INTEREST

The City partnered with community-based organizations including La Clinica de la Raza, Roots Community Health Clinic, and Allen Temple Baptist Church to provide testing services. Multiple City departments, including the Oakland Library, Oak311, Digital Services, Violence Prevention and the Fire Department, distributed COVID-19 testing information across various mediums, including radio, phone hotlines, digital outreach and distribution of printed material in multiple languages (see *Attachment A*).

COORDINATION

This report was prepared by the Finance Department with input from Risk Management, the Budget Bureau, and the Chief Resilience Officer, who led the City's efforts to expand testing services now subject to reimbursement.

SUSTAINABLE OPPORTUNITIES

Economic: This agreement would provide needed funds to the City and La Clinica de la Raza that would not otherwise be available.

Environmental: There are no environmental opportunities associated with this report.

Race & Equity: Upon its formation, the Community Resilience Branch immediately set a goal to ensure all residents have equitable access to COVID-19 testing, particularly Black and Latino residents given the overrepresentation of COVID cases and deaths in those communities. By partnering with trusted institutions like La Clinica, Roots Community Health Clinic, Allen Temple Baptist Church and Community Organized Relief Effort, the City quickly mobilized to open and support testing sites targeting community needs, like the Bay Area's first pedestrian-only site at Roots Community Clinic or the large Allen Temple Baptist Church site that had evening hours to accommodate varying work schedules.

These efforts contributed to Oakland's recognition as being one of the few cities that did not have longer waiting times and/or understaffed testing centers in communities of color. Across the U.S., people of color were more likely to experience longer wait times and understaffed testing center. However, according to an extensive review of testing sites by
FiveThirtyEight.com (https://abc7news.com/covid-19-testing-black-latino-bay-area/6330018/), Oakland and San Francisco testing locations near mostly Black census blocks were an estimated 21% less busy – on average – than testing sites near mostly-white neighborhoods. In the city's mostly Hispanic neighborhoods, the testing centers were about 4% less busy than those serving majority-white neighborhoods. The analysis found only four cities across the U.S. where minority neighborhoods were being served by less busy testing sites.

The City, in partnership with the Mayor's Office, also actively participated in the COVID-19 Racial Disparities Task Force, which advocated for initiatives and policies that promote greater COVID-19 equity.

Staff recommends that the City Council approve a resolution (1) authorizing a Memorandum of Understanding with the County of Alameda for City to receive funds in an amount not to exceed \$778,549 as reimbursement for providing COVID-19 testing services, and (2) appropriating said funds, and (3) awarding a pass-through grant agreement in an amount not to exceed \$73,474 to La Clinica de La Raza as reimbursement for providing COVID-19 testing services.
