#### **RECOMMENDATION**

Staff Recommends That The City Council Adopt A Resolution Accepting The Selection Panel's Slate Of One Alternate Police Commissioner (Jesse Hsieh) To Serve On The City Of Oakland Police Commission.

#### **EXECUTIVE SUMMARY**

In accordance with the City Charter, City Council approval of the resolution will accept the Selection Panel's decision to appoint Jesse Hsieh as an Alternate Commissioner on the Oakland Police Commission. If approved, Mr. Hsieh will assume the current vacant Alternate Police Commissioner seat, with a term ending on October 16, 2022.

#### **BACKGROUND / LEGISLATIVE HISTORY**

City Charter Section 604 (Police Commission) was first established by voter approval at the November 8, 2016 election, and later amended at the November 3, 2020 election. The ballot measures (also referred to as Measure LL and Measure S 1) established a seven-member Police Commission, with two alternate commissioners, charged with overseeing the Oakland Police Department (OPD) to ensure that its policies, practices and customs meet national standards of constitutional policing. Duties of the Police Commissioners include overseeing the Community Police Review Agency (CPRA), which conducts investigations into allegations of officer misconduct; overseeing the Office of the Inspector General (OIG), which performs independent audits of OPD; proposing changes to, approving, or rejecting current or proposed OPD policies; removing the Chief of Police for cause; as well as other duties.

The measures also established a nomination process whereby a nine-person Selection Panel would be responsible for nominating four (4) Commissioners and one (1) Alternate Commissioner to the Police Commission. The Mayor is also responsible for nominating three (3) Commissioners and (1) Alternate Commissioner. All nominations are subject to City Council approval. The Mayor and each City Council Member nominate an individual to serve on the Selection Panel. The Selection Panel meets as needed to determine its nomination process and review candidates wishing to serve on the Police Commission.

On December 1, 2020, the City Council adopted Resolution No. 88387 C.M.S., confirming James Jackson as a Mayoral appointee to the Police Commission; however, Mr. Jackson later resigned his position thereby creating a vacancy on the Police Commission.

At its meeting on March 11, 2021, the Oakland Police Commission voted to fill the vacancy created by Mr. Jackson by elevating David Jordan, then an Alternate Commissioner, to the role of Commissioner. The action created a new vacancy on the Police Commission for an alternate member seat. Commissioner Jordan is a Selection Panel nominee and served as an Alternate Commissioner since October 17, 2019, prior to advancing as a Commissioner. Mr. Jordan's Alternate Commissioner nomination was approved by the City Council in Resolution No. 87840 C.M.S. on September 17, 2019.

#### **ANALYSIS AND POLICY ALTERNATIVES**

Per City Charter Section 605(c)(8), the Selection Panel was tasked with nominating a candidate to fill the vacant Alternate Commissioner seat since that position was previously held by a Selection Panel appointee.

The Selection Panel conducted an expedited interview process in nominating Jesse Hsieh as an Alternate Commissioner. During their 2020 nomination process, six candidates, including Mr. Hsieh, were considered finalists but were ultimately not selected by the Selection Panel as they made two nominations to the Police Commission in August 2020. Those six candidates were considered reserve pool applicants by the Selection Panel and would receive first consideration should a vacancy occur in late-2020 or early-2021.

Three of the six reserve pool candidates accepted an interview with the Selection Panel on April 19, 2021. After completion of the interviews and deliberation, the Selection Panel voted unanimously to nominate Mr. Hsieh as an Alternate Commissioner.

Should Mr. Hsieh's appointment be confirmed by the City Council, he will be eligible to immediately serve on the Police Commission. Mr. Hsieh will assume the vacant term ending on October 16, 2022, and Mr. Hsieh will be eligible to serve an additional three-year term should he be nominated by either the Selection Panel or Mayor in the future, subject to City Council approval.

If the City Council does not accept or reject Mr. Hsieh's nomination within sixty (60) days, he shall be deemed appointed by way of City Charter Section 604(c)(3)(c).

#### FISCAL IMPACT

There is no direct fiscal impact associated with City Council action on this report.

#### Please respond (in writing) to the following questions:

1. Please describe any life work and significant community volunteer experiences that prepare you to contribute to the work of the Commission.

For the last fourteen years I have worked with people that have had to interact with the police. As a law student and new attorney, I helped clients legally clean up their record to avoid the stigma of contact with law enforcement. As a deputy public defender for the last eight years, almost every client of mine has contacted a police officer. Through my clients, I have gained great insight into how the police interact with the innocent and the guilty alike.

I am also familiar with law enforcement tactics and practices. As a public defender I review police reports, investigations, body camera footage, and department policies daily. I have handled cases from the simple drug possession to homicides; from traffic stops to cases involving months of surveillance. It is my job to be an expert in how the police handled an investigation and then to think critically about that investigation from an outsider's perspective: to determine what went right, what went wrong, and what could have been done better.

In what spare time I have, I sit on boards and committees that require me to work with others and build consensus to achieve common goals. I am the current vice president of the Asian American Criminal Trial Lawyers Association, a nonprofit board of Asian American criminal defense attorneys, judges, and law students. In that capacity I work with other board members to put together trainings and programs for Asian Americans in the legal profession. I am also part of the Public Defender's Office's Racial Justice and Diversity Committee, Training Committee, and Union Executive Board.

2. Please describe your contacts or experiences with the Oakland Police Department.

Outside of work, I have had minimal contact with members of the Oakland Police Department. Once, I was pulled over for speeding on Martin Luther King Jr. Way. By then, I knew how to stay on an officer's good side: two hands on the wheel, make no sudden movements, describe my actions before doing them, and never mention that I am a lawyer. I still ended up with a ticket but one with a lesser violation for my "cooperation."

In the past, I have reviewed a few police reports and body camera footage from the Oakland Police Department.

Clients who have talked to me about their experiences with the Oakland Police Department have generally conveyed lukewarm to negative experiences with OPD.

RESOLUTION ACCEPTING THE SELECTION PANEL'S SLATE OF ONE ALTERNATE POLICE COMMISSIONER (JESSE HSIEH) TO SERVE ON THE CITY OF OAKLAND POLICE COMMISSION.

WHEREAS, On November 8, 2016, Oakland voters approved Measure LL – establishing a Police Commission with 83.19% (137,032 votes) in favor of the measure; and

WHEREAS, Measure LL established City Charter Section 604 which created a sevenmember Police Commission to oversee the Oakland Police Department's policies and procedures and the Community Police Review Agency that investigates police misconduct and recommends discipline; and

WHEREAS, City Charter Section 604(c)(2) required the Mayor to appoint three Oakland residents as regular members of the Commission and one Oakland resident as an alternate member and to submit those names to the City Council for approval; and

WHEREAS, City Charter Section 604(c)(3) established a nine-member Selection Panel to review applications, interview applicants, and submit a slate of four Oakland residents as regular members of the Police Commission, and one Oakland resident as an alternate member, to the City Council for approval; and

WHEREAS, The initial members of the Police Commission were accepted by the City Council on October 17, 2017, and held their first meeting on December 13, 2017; and

WHEREAS, The initial members of the Police Commission served staggered terms of two, three, or four years; subsequent appointments serve terms of three years; and for vacancies that occur for reasons other than the expiration of a term, the Commission shall select one of the alternates to replace the regular member for that regular member's remaining term of office; and

WHEREAS, Mr. James Jackson resigned his position of Police Commissioner after being confirmed by the City Council on December 1, 2020, and the Police Commission appointed Mr. David Jordan at its meeting on March 11, 2021 to replace Mr. Jackson and to serve his remaining term through October 16, 2023; and

WHEREAS, Since Mr. David Jordan was a Selection Panel appointee, the Selection Panel has the responsibility of appointing another Alternate Police Commissioner to serve Mr. Jordan's remaining term through October 16, 2022; now therefore be it

**RESOLVED:** That pursuant to City Charter Sections 604(c)(3) and 604(c)(8), the City Council hereby accepts Mr. Jesse Hsieh as the Selection Panel's Alternate Police Commissioner appointment to serve on the Police Commission through October 16, 2022.
