RECOMMENDATION

Staff Recommends That City Council Adopt A Resolution Amending Resolution No. 88793 C.M.S., Which, Among Other Things, adopted The Fiscal Year 2021- 22 Workforce Development Budget And Authorized Grant Awards To Providers, To Authorize A Grant Award To Spanish Speaking Unity Council Of Alameda County, Inc. In The Amount Of \$175,000, And A Grant Award Increase Of \$25,000 To The Oakland Private Industry Council Inc.

BACKGROUND/LEGISTLATIVE HISTORY

The Oakland Workforce Development Board (OWDB) contracts with experienced local nonprofit organizations to provide workforce development services for recently displaced and long-term unemployed adults and low-income youth and young adults between the ages of 16-24.

The OWDB budget is made up of multiple funding streams that support workforce development efforts, including Federal, State, City of Oakland, and miscellaneous grants from private businesses and philanthropic support.

The Oakland City Council adopted the OWDB Fiscal Year (FY) 2021-22 OWDB Budget at its Special meeting held on July 26, 2021¹.

ANALYSIS AND POLICY ALTERNATIVES

The Oakland City Council desires to amend the FY 2021-22 OWDB Budget adopted on July 26, 2021, to award \$175,000 of General Funds to the Spanish Speaking Unity Council and to increase the award of General Funds to the Oakland Private Industry Council by \$25,000, from \$235.000 to \$260,000.
