The City shall annual provide notification to all Covered Units information, but not limited to, the amount of the annual CPI Rent Adjustment, Banking (as an allowable increase without landlord petitioning) and information on how to get information to challenge a rent increase and other questions about rents and Rent Adjustment Program procedures.*
