Pursuant to 401 of the Charter, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled action for the sum of One Hundred Ninety-Five Thousand Dollars (\$195,000.00), payable to Plaintiff Ke'Van Pope and to Robert Henry Blumenthal, his attorney of record.

This lawsuit arises out of allegations of excess force by Oakland Police officers. Mr. Pope sustained a gunshot wound and permanent physical injuries as a result of the incident. Settlement authority in this matter was extended by the Council in a sum not to exceed \$225,000.00

The settlement is recommended to avoid the risk of an adverse verdict at trial and the additional exposure for attorneys' fees should that occur.
