(2) Amend The City's Zoning Maps To Map These Proposed Zones In Areas In The City That Currently Have The General Plan Land Use Designations Of Business Mix And General

Industrial/Transportation;

(3) Amend Chapter 17.10 "Use Classifications";

(4) Add Chapter 17.100 "S-19 Health And Safety Protection Overlay Zone"; And Amend Zoning Map

To Add Overlay;

(5) Amend Chapter 17.120 "Performance Standards"; And

(6) Amend The "Guidelines For Determining Project Conformity With The General Plan And Zoning

Regulations" To Reflect The New Zones
