RESOLUTION NO. 91029⁺ C.M.S.

RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR:

- 1) TO APPLY FOR AND ACCEPT THE FIRST 5 ALAMEDA COUNTY EARLY CARE AND EDUCATION EMERGENCY GRANT IN AN AMOUNT NOT TO EXCEED FIVE HUNDRED THOUSAND DOLLARS (\$500,000) TO PROVIDE STIPENDS TO ELIGIBLE EARLY CHILDHOOD AND FAMILY SERVICES DIVISION STAFF AND OTHER ALLOWABLE EARLY CHILDHOOD EXPENDITURES EFFECTIVE JULY 1, 2025, THROUGH JUNE 30, 2026; AND
- 2) TO ACCEPT ADDITIONAL EARLY CARE AND EDUCATION EMERGENCY GRANT FUNDING THAT BECOMES AVAILABLE FOR THE SAME PURPOSES DURING THE SAME CONTRACT TERM; AND
- 3) TO ENTER INTO AN AGREEMENT WITH CALIFORNIA SCHOOL AGE CONSORTIUM (CALSAC) TO SERVE AS THE FISCAL SPONSOR FOR THE CITY OF OAKLAND AWARD FROM FIRST 5 ALAMEDA COUNTY'S EARLY CARE AND EDUCATION EMERGENCY GRANT, TO MANAGE AND DISBURSE STIPENDS TO ELIGIBLE EARLY CHILDHOOD AND FAMILY SERVICES STAFF AND OTHER GRANT RELATED EXPENDITURES.

WHEREAS, the City of Oakland wishes to apply, accept, and authorize a contract with First 5 Alameda County, to receive Measure C First 5 Early Care and Education Emergency Grant funding in an amount not to exceed \$500,000 to provide one-time stipends of a minimum of \$1,000 but up to \$5,000 depending on the final grant award amount, to educators and other eligible staff; to purchase education materials and supplies; to cover fiscal sponsor administrative fees, and for family education support activities, effective July 1, 2025, through June 30, 2026; and

WHEREAS, the City of Oakland may apply funding from the Measure C First 5 Early Care and Education Emergency Grant to the eligible expense term of January 1, 2025, through June 30, 2026, a funding term that First 5 Alameda County proposes for budgeting eligible expenses for the contracted award; and

WHEREAS, the City of Oakland wishes to enter into an agreement with California School Age Consortium (CalSAC), to serve as the fiscal sponsor for the City of Oakland award

from the First 5 Early Care and Education Emergency Grant, to manage and disburse stipends to eligible Early Childhood and Family Services staff and other grant-related expenditures; now, therefore, be it

RESOLVED: That the City Administrator or their designee is hereby authorized to enter into an agreement with First 5 Alameda County, to receive Measure C Early Care and Education Emergency Grant funding in an amount not to exceed \$500,000 to provide one-time stipends of a minimum of \$1,000 but up to \$5,000 to educators and other eligible center staff; to purchase education materials and supplies; to cover fiscal sponsor administrative fees, and to support family education support activities, effective July 1, 2025, through June 30, 2026; and be it

FURTHER RESOLVED: The City of Oakland may apply funding from the Measure C First 5 Early Care and Education Emergency Grant to the eligible expense term of January 1, 2025, through June 30, 2026, a funding term that First 5 Alameda County proposes for budgeting eligible expenses for the contracted award; and be it

FURTHER RESOLVED: That the City Administrator or their designee is hereby authorized to enter into an agreement with California School Age Consortium (CalSAC), to serve as the fiscal sponsor for the City of Oakland award from the First 5 Early Care and Education Emergency Grant, to manage and disburse stipends to eligible Early Childhood and Family Services staff and other grant related expenditures; and be it

FURTHER RESOLVED: That should additional funds be received from First 5 Alameda County for the same purposes within the same contract term, the City Administrator or their designee is hereby authorized to accept such funds during the term July 1, 2025, through June 30, 2026; and be it

FURTHER RESOLVED: That the City Council hereby authorizes the City Administrator or their designee to conduct all negotiations, execute and submit all documents, including but not limited to applications, agreements, amendments, modifications, payment requests, and related actions, which may be necessary to apply for and accept the aforementioned contract.
