RESOLUTION NO. 91033 C.M.S.

RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO ENTER INTO AN MEMORANDUM OF UNDERSTANDING (MOU) WITH THE SANTA CLARA STADIUM AUTHORITY AND THE CITY OF SANTA CLARA FOR THE OAKLAND POLICE DEPARTMENT TO PROVIDE TACTICAL SUPPORT AND SECURITY FOR SUPER BOWL 60 ON FEBRUARY 8, 2026 AND THE FIFA WORLD CUP EVENT FROM JUNE 11, 2026 TO JULY 19, 2026

WHEREAS, Santa Clara Stadium Authority (Authority), a Joint Powers Authority, and City of Santa Clara (Santa Clara), a chartered municipal authority, are the parties in this MOU; and

WHEREAS, both Super Bowl 60 is occurring on February 8, 2026, and FIFA World Cup is occurring from June 11 to July 19, 2026, in Santa Clara, CA; and

WHEREAS, pursuant to authority set forth in Government Code sections 54981 and 55632, and City Charter Section 1108, Authority and Santa Clara seeks additional law enforcement services, and City of Oakland agrees to provide additional law enforcement services for periodic events at the Santa Clara Stadium site; and

WHEREAS, Authority and Santa Clara are desirous of Oakland Police Department (OPD) providing supplemental tactical support for Super Bowl 60 and FIFA World Cup events at the Santa Clara stadium site and surrounding areas; and

WHEREAS, City of Oakland is agreeable to rendering supplemental law enforcement services in the form of tactical support and security; and

WHEREAS, the classification and number of personnel needed, and the number of hours needed, will be determined and mutually agreed upon, in writing between City of Oakland, Authority, and Santa Clara Police Chief prior to each event; and be it

RESOLVED: That deployment of Oakland Police Department personnel for any event shall not reduce on-duty staffing levels for patrol or specialized units below OPD's established operational baseline; and be it

RESOLVED: That the City Council authorizes the City Administrator to enter into MOU with Agency and Santa Clara in order to contract OPD's services for law enforcement functions for Super Bowl 60 and FIFA World Cup 2026; and be it

FURTHER RESOLVED: That the City Administrator is authorized to conduct all negotiations, applications, agreements, extensions and related actions consistent with the purposes of this Resolution for the purpose of executing the MOU.


