RECOMMENDATION

Staff Recommends That The City Council Conduct A Public Hearing And Upon Conclusion Adopt An Ordinance Amending Ordinance No. 13848 C.M.S. (Which Adopted The Fiscal Year 2025-26 Master Fee Schedule), As Amended, To Establish, Modify And Delete Fees And Penalties Assessed By The City Of Oakland For Fiscal Year 2026-27.

REASON FOR SUPPLEMENTAL


At the June 2, 2026, meeting of the Oakland City Council, the Council voted to advance this item to the June 16, 2026, City Council meeting for passage. During the June 2, 2026 meeting however, a technical error was identified in the proposed Master Fee Schedule and corrected verbally on the record. Specifically, within the Economic and Workforce Development Department fee schedule, Exhibit A: A-10, Page M-3, Section G., Overtime Service Fee for Re-Inspection After Failing Secondary Inspection, for both 1. Cannabis Officer and 2. Special Activity Permit Inspector fee categories, the proposed unit of measure was incorrectly listed as "Per Hour." The correct unit of measure is "Per Incident." This supplemental report is provided to document the corrections made on the record during the June 2, 2026, meeting.
