### A RESOLUTION CONFIRMING THE MAYOR'S REAPPOINTMENTS OF KAREN ZUKOR, CHIYE AZUMA, AND ALEX WEINBERG TO THE LIBRARY COMMISSION

**WHEREAS**, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

**WHEREAS**, Ordinance No. 8064 C.M.S. adopted November 13, 1969 and amended by Ordinance Nos. 11730 C.M.S., 12879 C.M.S., 13174 C.M.S., 13560, and 13757 C.M.S., establishes the Library Commission, as recently renamed from the Library Advisory Commission, to advise and make recommendations on the operation and future development of the library system and to act as a liaison between the Library Department and the Mayor and City Council; and

**WHEREAS**, the Library Commission consists of fifteen (15) members serving not more than two consecutive three-year terms; and

**WHEREAS**, the Honorable Mayor Barbara Lee has appointed Karen Zukor, Chiye Azuma, and Alex Weinberg to serve three-year terms subject to confirmation by the City Council; now, therefore, be it

**RESOLVED:** That pursuant to City Charter Section 601, the City Council hereby confirms the Mayor's reappointments to the Library Commission of:

**Karen Zukor**, to serve a three-year term beginning March 1, 2026 and ending February 28, 2029, filling the seat previously held by themselves.

**Chiye Azuma**, to serve a three-year term beginning March 1, 2026 and ending February 28, 2029, filling the seat previously held by themselves.

**Alex Weinberg**, to serve a three-year term beginning March 1, 2026 and ending February 28, 2029, filling the seat previously held by themselves.


