**RESOLUTION NO. 91201 C.M.S.**

**A RESOLUTION AUTHORIZING: (1) GRANT AGREEMENTS WITH SERVICE PROVIDERS COMPETITIVELY SELECTED FOR WORKFORCE INNOVATION AND OPPORTUNITY ACT (WIOA) PROGRAM SERVICES FOR FISCAL YEARS 2026–2029 IN A TOTAL AMOUNT NOT TO EXCEED TWO MILLION SIX HUNDRED FIFTY THOUSAND DOLLARS (\$2,650,000) FOR FISCAL YEAR 2026–2027 TO PROVIDE COMPREHENSIVE ADULT AND DISLOCATED WORKER, ONE-STOP OPERATOR, BUSINESS ENGAGEMENT, AND YOUTH SERVICES; (2) AMENDMENTS TO EXISTING WIOA AGREEMENTS TO EXTEND CONTRACT TERMS THROUGH JUNE 30, 2027, AND INCREASE FUNDING IN A TOTAL AMOUNT NOT TO EXCEED FIVE HUNDRED EIGHTY-FOUR THOUSAND ONE HUNDRED NINE DOLLARS (\$584,109); AND (3) GRANTS OF WIOA CONTINGENCY SET-ASIDE FUNDING TO SUPPORT COMMUNITY-BASED OUTREACH, REFERRALS, AND WORKFORCE STRATEGIES IN AN AMOUNT NOT TO EXCEED ONE HUNDRED TWENTY-FOUR THOUSAND DOLLARS NINE HUNDRED NINETY-NINE DOLLARS AND NINETY-NINE CENTS (\$124,999.99) TO OAKLAND PRIVATE INDUSTRY COUNCIL (OPIC) IN PARTNERSHIP WITH SPANISH SPEAKING UNITY COUNCIL OF ALAMEDA COUNTY AND IN AN AMOUNT NOT TO EXCEED ONE HUNDRED TWENTY-FIVE THOUSAND DOLLARS (\$125,000) TO LAO FAMILY COMMUNITY DEVELOPMENT IN PARTNERSHIP WITH ROOTS COMMUNITY HEALTH CENTER, SUBJECT TO APPROVAL BY THE OAKLAND WORKFORCE DEVELOPMENT BOARD**

**WHEREAS**, the Workforce Innovation and Opportunity Act (WIOA) authorizes federal funding to support workforce development services for adults, dislocated workers, youth, and employers; and

**WHEREAS**, the City of Oakland is a Governor-designated local workforce development area and receives annual allocations of WIOA Title I funds administered by the California Employment Development Department; and

**WHEREAS**, the Oakland Workforce Development Board (Board), established pursuant to WIOA, is responsible for overseeing the planning, procurement, and delivery of WIOA-funded workforce services within the City of Oakland; and

**WHEREAS**, on December 5, 2025, the City of Oakland, on behalf of the OWDB, issued a competitive Request for Proposals (RFP) for WIOA Title I Adult, Dislocated Worker, and Youth Program Services for FY 2026-2029 across four service categories:

1. America's Job Centers of California (AJCC) Comprehensive Career Centers;
2. One-Stop Operator Services;
3. Business Intermediary Services;
4. Youth Program Services; and

**WHEREAS**, proposals were due on January 16, 2026, and were reviewed through a two-step evaluation process consisting of a compliance review and a qualitative scoring process, in accordance with the evaluation criteria published in the RFP; and

**WHEREAS**, based on proposal scoring and system considerations, staff is recommending awarding new grant agreements in an amount not to exceed Two Million Six Hundred Fifty Thousand Dollars (\$2,650,000) to selected providers to deliver WIOA program services beginning July 1, 2026; and

**WHEREAS**, staff is recommending amending existing WIOA agreements with current WIOA providers identified below in Table 2 to extend contract terms for one (1) year and increase funding in an amount not to exceed Five Hundred Eighty-Four Thousand One Hundred Nine Dollars (\$584,109) to maintain continuity of services during the transition to new contracts; and

**WHEREAS**, to support efficient administration and coordinated service delivery across multiple sites, staff is recommending issuing a single contract award per provider, where applicable; and

**WHEREAS**, on November 6, 2025, the Oakland Workforce Development Board approved the proposed grant agreements and amendments proposed; and

**WHEREAS**, to provide for further equitable community representation in workforce access, staff is recommending granting available WIOA contingency set-aside funding be allocated to support community-based outreach, referrals, and workforce strategies in an amount not to exceed One Hundred Twenty-Four Thousand Nine Hundred Ninety-Nine Dollars and Ninety-Nine Cents (\$124,999.99) to Oakland Private Industry Council (OPIC) in partnership with the Spanish Speaking Unity Council of Alameda County and in an amount not to exceed One Hundred Twenty-Five Thousand Dollars (\$125,000) to Lao Family Community Development in partnership with Roots Community Health Center, subject to approval of the Oakland Workforce Development Board; now, therefore, be it

**RESOLVED:** That Oakland City Council hereby approves the recommended awards for WIOA-funded services for Fiscal Years 2026–2029, as described in the table below:

**FURTHER RESOLVED:** That the City Council authorizes an additional allocation of available WIOA contingency set-aside funding be allocated to support community-based outreach, referrals, and workforce strategies through partnerships between Oakland Private Industry Council (OPIC) as prime grantee and the Spanish Speaking Unity Council of Alameda County as subgrantee in an amount not to exceed One Hundred Twenty-Four Thousand Nine Hundred Ninety-Nine Dollars and Ninety-Nine Cents (\$124,999.99), and between Lao Family Community Development as prime grantee and Roots Community Health Center as subgrantee in an amount not to exceed One Hundred Twenty-Five Thousand Dollars (\$125,000), subject to approval of the Oakland Workforce Development Board; now

**FURTHER RESOLVED:** That the City Council hereby authorizes the City Administrator to negotiate and enter into such agreements with competitively solicited providers in the not to exceed amounts identified in Table 1 above with an option to renew with no additional funds for an additional twelve (12) months through June 30, 2028, consistent with the adopted budget; and be it

**FURTHER RESOLVED:** That the City Council hereby authorizes the City Administrator to negotiate and enter into amendments with current WIOA providers in the not to exceed amounts identified in Table 2 above for a term through June 30, 2027; and be it

**FURTHER RESOLVED:** That WIOA Title I formula funding will be budgeted in the Workforce Investment Act Fund (2195), Workforce Development Organization (85311), Expenditure accounts (54912), in various Projects to be determined, and in Workforce Program (SC03); and be it

**FURTHER RESOLVED:** That given possible variances in WIOA allocations from the U.S Department of Labor and the State EDD, the City Council is authorized to accept additional WIOA funding allocations in FY 2026-27 and authorize staff to appropriate additional funding with approval of the Oakland Workforce Development Board; and be it

**FURTHER RESOLVED:** That the City Council hereby authorizes the City Administrator, in their reasonable discretion and accordance with WIOA Section 133(b)(4) and federal Uniform Guidance (2 CFR Part 200), to reallocate WIOA training funds between contracts within a given funding stream (e.g., Adult, Dislocated Worker, or Youth) and subject to the concurrence of the Oakland Workforce Development Board to ensure efficient use of resources and maintain continuity of services, provided that such reallocations are consistent with grant requirements; and be it

**FURTHER RESOLVED:** That the City Council hereby authorizes the City Administrator in their reasonable discretion and subject to the concurrence of the Oakland Workforce Development Board to reallocate expenditure budget of workforce development funds to be moved between projects within the fund in a manner consistent with the Resolution and its basic purposes; and be it

**FURTHER RESOLVED:** That the City Council hereby authorizes the Administrator to spend such funds in Fiscal Year 2026-2027 and take other action with respect to the authorized contracts consistent with the Resolution and its basic purposes, subject to review and approval by the City Attorney's Office.
